Each of these guys brings a different slant to what they observed at the Conference. Both give you a flavor for the event's high-priced propaganda undercurrent.

It should be pointed out that the "Fast Facts" sidebars included herein give a picture of the sheer decadence of this pageant for the Elite. Moreover, comparing our reporters' stories with the avalanche of superlatives that gushed profusely from the Bakersfield Californian newspaper—you'd think the posse of Bakersfield Californian "reporters" attended a different event from what we describe below.

A CONFERENCE OF THE "HAVES"

Five years ago the Bakersfield Business Conference, sponsored by the Bakersfield law firm of Borton, Petrini & Conron, had about five hundred attendees. This year, on October 15th, the event was spread out over twenty-seven acres on the grounds of Cal State University. The numbers had grown into the world's largest tent containing twelve-thousand-five-hundred people who paid three hundred dollars a head to hear eighteen world-class speakers and entertainers. There were several smaller tents housing eating and refreshment areas, as well as the press. The entire grounds were lavishly decorated with flowers, American flags, and white picket fences. There were state-of-the-art video monitors and speakers placed everywhere, so that no matter where you were, you could hear and see what was going on. The people who attended were finely coiffured and dressed in yuppie attire for the most part.

This event was titled as a "business conference". However, the only business discussed was that of "The New World Order", seeking to reassure the "haves" in attendance that this new world "arrangement" would allow them to prosper like never before. All of the speakers who have any type of political affiliation seemed to be reading from the same script—praising NAFTA, GATT and the miracles of free trade. They all stressed the right and the duty of the U.S. to impose, militarily or otherwise, a form of Democracy, on any country that is out-of-step with the New World Order. Although the actual term "New World Order" was used sparingly, the intent of these men to that end was unmistakable.

I will give you a rundown of the speakers that I heard and some comments about each of them.

Rich Little: He brought the house down with his impersonations. The best ones were of the former Presidents, and then Bill Clinton. He sent them to new heights of caricature with hilarious, witty and clever imitations. What a treat!

George Will: George was the speaker who got my vote as the nearest to reality of the ones speaking on political issues. He made some excellent points about the moral and ethical breakdown of society and the family unit. Starting in the 60s, with the Government welfare programs, he stated that they served to promulgate and direct the social catastrophe that we are witnessing today. He lost me when he pronounced that parents who don't immunize and vaccinate their children were irresponsible. (George, do your homework on that subject and come back later.) [See pgs. 2-27, Oct. 18, 1994 CONTACT.]

Sam Donaldson: Sam harped on the idea that his friend, George Will, only looked at the bad side of government. He said that we should not forget the good things Congress and the Clinton Administration are doing. Wake up Sam, Elvis has left the auditorium.

James Baker III: This guy was scary. He ranted and raved about Clinton having to take control over foreign policy and if he couldn't do so, he should turn it over entirely to the Secretary of State. Does Jimmy think that he's still Secretary of State? He said "If you can't pull the trigger, don't point the gun." This was a reference to Clinton threatening to use military force in Bosnia and not following through. He justified this by saying "The Constitution guarantees the President the right to declare war." He must be referring to the New-States Constitution, because our Constitution says, in Article I, Section 8, that Congress alone has the power to declare war.

Dr. Henry Kissinger: What can you say about Hank that we haven't already said? Heir Weishaupt—er...ah...I mean, Henry, remains timeless and well-preserved. With his usually deep, thickly accented drone, Dr. Kissinger made a twenty-minute disjointed speech. I think his programming is geared mainly toward writing and question & answer sessions rather than giving speeches. His main points, as usual, reinforced the idea of preserving our national security interests, even if it means committing military forces. However, he stated that we can't be the policemen of the world. Say what? I was surprised to overhear other reporters commenting on the contradictions of his statements, too. Whew, it's a good thing that the CONTACT readers are not the only ones who can recognize doublespeak when they hear it. However, as Mr. Swinton of the *New York Times* pointed out in the '50s [see p.8], these mainstream reporters will keep their politically incorrect views to themselves.

Before his speech, Dr. Kissinger made a brief appearance in the press tent where Rick Martin and I were camped most of the day. I managed to get his attention for the last question of the session.

BM: "Brent Moorhead for the *CONTACT* newspaper. In your opinion, Dr. Kissinger, what do you feel gives the U.S. the right to interfere with Governments of other countries, whether or not we have a vested interest in them? Why do you feel it's necessary for us to intervene and to actually set up the type of government we feel they should have?"

HK: "What countries are you talking about?"

BM: "Haiti, in particular, and Panama."

HK: “I believe the United States has national interests. Some of those are security interests; some of those are moral interests. I can imagine that I would believe the United States should defend it’s security interests, by force if necessary. And if there are Governments like Saddam Hussein, that represent a permanent threat to international security, it seems to me that this justifies American action. In other Governments, where we have preferences, and in which, in the area of discretion that a big power government has, we have every right and every duty to express our preferences. I would be careful about using military power. Now, in Panama, where there is the Panama Canal, I can see the security issue involved when you have a Government of the kind against which we acted previously. In Haiti, I have not favored the use of military power.” Blah, blah blah.

Jay Leno: Jay was very funny and he seemed a little less inhibited than on his nightly TV show.

Peter Jennings: Peter seems to see the world through rose-colored glasses. Although, he did express concern about the polls—which show only 22% of the American people believe that the nightly news shows give them the truth. Hooray! People are waking up.

Shirley MacLaine: This lady was the most insightful and visionary of all the speakers. She expressed the idea that we need to get in touch with our “Inner Selves” and also work on raising the consciousness of all on the planet. Shirley proved to have a clear and real understanding of life. Sadly, her words went way over the heads of most listeners.

Brian Mulroney: He praised himself profusely for setting up the Canadian-U.S. Free Trade Agreement and then later NAFTA. He lied about how the Canadian-U.S. Free Trade Agreement created jobs and boosted the economy in Canada.

Larry King: Larry told funny stories about his life.

Lord James Callaghan: This former Prime Minister of England bored everyone to death with his political and intellectual analysis of the world and the role of the U.S. in the new order of things. Drier than an ol’ bone.

General Colin Powell (Ret.): What an incredible disappointment it was to hear the soft spoken, articulate former head of the Joint Chiefs Of Staff reiterate the gospel of the New World Order. He was introduced with great fanfare and pomp. Watch out, they are grooming this guy for a higher political something and he has taken to it like a duck to water.

Once again, for the 10th year running, the law firm of Borton, Petrini & Conron sponsored the Bakersfield Business Conference, held on the campus of Cal State Bakersfield. Covering 27 acres, this year’s event was held in “the largest tent on Earth”. Amidst the prominent display of red-white-

and-blue, abundant floral arrangements, fountains, and booths containing pastries and coffee, the conference began with singing from the All American Boys' Chorus.

The one-day conference brought in 12,500 people, at \$300 each, to listen to: Rich Little, George Will, Sam Donaldson, James Baker III, Dr. Henry Kissinger, Jay Leno, Peter Jennings, Shirley MacLaine, Brian Mulroney, Larry King, Lord James Callaghan, Gen. Colin Powell, Neil Armstrong, Mike Collins and Buzz Aldrin.

The facilities were impeccably laid out, as usual, with every attention to detail. I overheard one person describe this event as an "adult Disneyland". I must say that, compared to last year, this year's conference somehow felt "flat" to me—it lacked a certain electricity or passion or, perhaps, just heart. I can't really put my finger on it more clearly than that, just a feeling of "no seasoning" to the soup.

Rich Little walked onto the stage and lost no time in saying, "I could have come on as Jack Benny, but not at these prices."

"I thought about coming as Ronald Reagan, but I couldn't remember the date."

"I could have come as Bill Clinton, but I didn't want to upset you." And on he went, a very funny man.

As Jack Nicholson, he said, "You want the truth? You can't handle the truth." An interesting thing to say to this particular group of people!

George Will gave a dry but rapid-fire commentary on the internal state of our country—or should I say, our country's crisis. His sharp criticism of the Clinton Administration was many-faceted and thorough.

"The country today is markedly more conservative. Faith in Government has collapsed," Will said.

Will hit America's educational difficulties hard. Stating that the three Rs, now, represent: Racism, Reproduction and Recycling! Will went on to say that children should know how to spell condom before such are distributed to them.

Will said that we have entered broad-scale social regression amidst overwhelming prosperity. Much was accredited to the disintegration of the American family. **People are beginning to ask if Government isn't the disease which is pretending to be the cure.**

Will asked the question, "Why are we policing the streets of Haiti before we can police the streets of Bakersfield?"

Later, in the press tent, when asked, "What is the biggest problem affecting American children today?" Will replied, "American parents".

Jay Leno was so funny and so quick in his delivery of jokes that I was unable to stop laughing to write. Well done.

A youthful looking, well rested, Dr. Henry Kissinger entered the press tent flanked by security personnel. When asked, “What should our role be as international policemen,” he replied, “We should not be a global policeman”. (??)

When asked about the ratification of GATT, Kissinger replied, “Yes, I’m in favor of ratifying the GATT treaty. We stand for free trade.”

Dr. Kissinger mentioned that, some time ago, a woman came up to him and said, “I understand you’re a fascinating man. Fascinate me.” It didn’t go too well from then on.

“I have opposed the use of military force in Haiti,” Kissinger said. “Not because I think the spread of democracy is not important, but because no fundamental security threat is at stake.”

“We must develop a clear definition of our national interests,” Kissinger said. “We can’t be the global policeman. We can’t be a do-gooder. For what are we willing to expend our lives? For what are we willing to expend our treasures?” “We must look at what our interests are and what our capacities are,” he said. “There is a difference between foreign policy and psychiatry.”

Kissinger went on to say, “Leaders are responsible for their actions and, in the long run, will be judged by those consequences—not by public relations exercises.” And, “I agree with Jim Baker. We must end this debate between idealism and realism. This is an idealistic nation, but there is also a real world.”

Before leaving the press tent, *Dr. Kissinger was kind enough to sign the back of my CONTACT business card—see signature below his photograph.*

James Baker III delivered an address on domestic and foreign policy which was so distorted from truth and, in my opinion, flat wrong, that I did not continue taking notes. In a lengthy analysis of foreign policy that sounded like something from another planet I, simply put, just turned him off.

Peter Jennings took the stage and asked the \$10,000 question of the day: “**What do you have when a lawyer is up to his neck in cement? Not enough cement.**” He went on to deliver an often thoughtful examination of the media generally, and the role of the press in shaping the public’s perception of its government. Speaking somewhat through a successful anchor’s rose-colored glasses, Jennings was articulate and frequently “on-point”.

Coming onto the stage, Shirley MacLaine said, [paraphrasing and alluding to Reincarnation] “This is the finest gathering of people I’ve been to in the last 6,000 years.” She immediately proceeded to explain that her talk would appeal much more to the women in the audience than to the men.

In what proved, for me, to be the biggest surprise of the day, she then went on to deliver a spiritually-oriented, thought-provoking and soul-evoking talk which was penetrating in its insight and profound in its ramifications. Finally, someone on a higher wavelength.

Shirley was, hands down, the best speaker at this conference. When she spoke, the tent was very quiet—while some people roamed about freely. In the press tent it was likewise quiet. It was as though the entire speech went about two feet over the listening audiences head. Or perhaps they were just reflecting on what she was suggesting—I would like to think that is the case, although I fear the former is closer to the truth of it.

Speaking of such things as meditation, spiritual technology, a new soul physics, a higher soul, super-consciousness, and the need for demanding quiet time for self, MacLaine spoke of the need to become more spiritually aware in an ever-changing and hectic world.

Continuing, she said, “The universe within us is so much vaster than the universe without.”

Before leaving the press tent, she said to the abundant media present: “You know, you guys are so far behind where the general population of America is—you really should catch up.” To which she should have received a standing ovation, but no such luck.

Larry King was amiable with the press, joking. His talk was very funny, talking about the old days in Brooklyn. His persona at this conference was much more relaxed and candid than he appears on his radio or television programs. Lots of laughs with his speech.

Brian Mulroney was a typical politician. I listened to him for over half-an-hour and I couldn’t glean a single morsel of substance from the hot air. He, of course, talked up NAFTA and GATT, and emphasized the fact that Canada is America’s largest foreign customer, at 22% of all exports, against Japan’s 10%. His words just kind-of blended together after a certain point.

Lord James Callaghan was so “captivating” in speaking about what is in our nation’s best interest and...zzzzzzzz...that I left for food during his speech. Sounded like very old, very stale rhetoric from the creaky vaults of the Upper Crust elite.

The person I had been looking forward to hearing all day was Gen. Colin Powell. Powell took the stage to all 14,000 on their feet, all waving American flags.

But it was all downhill from that point on. Gen. Powell delivered a cookie-cutter speech from the rubber-stamp presses of Washington, parroting the New World Order agenda and bestowing accolades for the status quo, including praise for the recent moves on Haiti and other current matters of national concern.

His speech was alarmingly disappointing, entirely uncreative, lacking in foresight, insight, higher political understanding or any concern what-so-ever for the Constitution.

Gen. Colin Powell really showed his colors at the Bakersfield Business Conference and it was not a pretty picture. Just another puppet to be controlled by the puppet masters. You can fool some of the people some of the time but you can’t fool all of the people all of the time—and this time wasn’t even a close call.

Taken as a whole, the Conference itself was a huge success. Those well dressed attendees heard a

heavy-hitting lineup of speakers that they wouldn't normally hear, particularly in the country town of Bakersfield, California. But one question does seem to linger in the air: "Where's the beef?" "Dan Quayle is working at a think tank. Let's hope they have a lifeguard on duty." — *Jay Leno*

POLICE CHIEFS' CONFERENCE OUTLINES PLANS TO IMPLEMENT "LEGAL" CONTROL by Rick Martin 10/20/94

ALBUQUERQUE, NM—In a precisely delivered speech which followed the day after President Clinton's [*see page 81 of last week's CONTACT*], Attorney General Janet Reno addressed the International Association of Chiefs of Police [IACP] Convention. Bestowing abundant honor and praise for state and local law enforcement efforts, Reno stated, "You have been there when it counts. You have been there in the most difficult times." Reno offered hope and encouragement stating, "The police are giving people confidence in government. They are the glue."

Reno then went on to outline five key areas of concern or focus for the coming year, namely: protecting police from attacks; making the asset-forfeiture program work—"together we'll make the asset-forfeiture program work for you"; working on anti-violence initiatives, especially for youth; devising an effective domestic narcotics strategy; and implementing the Crime Act "the right way".

Stressing that, "Now is no time to rest on our laurels," Reno stressed the importance of implementing the Crime Bill right away. "We must not, we can not, and we will not tolerate delay," Reno said.

The Attorney General cited some of the major aspects to the Crime Act including: "three strikes and you're out", money for 100,000 new officers, prison and "boot camp" construction and more. But she added, "None of it would make a difference if the new law isn't put into action quickly." Echoing the President's words, Reno likewise revealed the Achilles heel of the Crime Bill and ban on assault weapons—namely, seeing to it that Congress makes the funds available over the next year to IMPLEMENT these measures.

Immediately following Janet Reno was FBI Director Louis Freeh, former U.S. District Court judge, ex-prosecutor and former FBI agent. Freeh lost no time in reiterating concerns over drugs and violence in America. Freeh said, "These outrageous statistics have been fueled by guns and drugs." Adding, "Our enemies aren't stupid; they understand they can achieve their goals by acquiring market shares (turf)," he said. "The quest for market shares and new territories has brought drug gangs to places once thought to be immune."

Freeh assured those assembled that there will not be a merger of the FBI with the Drug Enforcement Administration, and went on to say that their working relationship was "complementary".

Director Freeh stated that he has moved 600 agents from desk jobs to working cases and has implemented the hiring of 436 new agents, the first hired since 1992. He spoke of the congressional bill passed 10 days ago called "Digital Telephony Act of 1994" which gives greater leeway for phone tapping by law enforcement agencies, including the FBI.

In a predictable approach, Freeh fell back on quoting crime statistics, stating that there has been a 371% increase in crime since 1970.

In justifying his travels abroad on behalf of the FBI, Freeh stated, in a very revealing comment, “We must recognize the disappearance of borders.” Please remember, this is the Federal Bureau of Investigation—it does not say the International Bureau of Investigation. Further justifying, Freeh said, “We have vital law enforcement issues at stake” and “there can be no doubt about the transnational nature of crime in the 1990s.”

“These international countries have asked for our assistance,” Freeh said, referring to his trip to nine Eastern European countries during the summer to discuss mutual law enforcement concerns.

While the cover-sheet on the press release concerning this IACP conference states: “Throughout its existence, the IACP has been devoted to the cause of crime prevention and the fair and impartial enforcement of laws with respect for constitutional and fundamental human rights.” The real agenda of this year’s conference seems far more ominous, with individual seminar topics such as: Cellular telephone wiretaps: essential to drug organization targeting [*Editor’s note: Let me jump in here briefly to remind you also that some of the radio frequencies being utilized in the recent buildup of the massive cellular telephone network also have a direct effect on the brain and can be utilized for covert mind-control activities; doesn’t that add an interesting spin to this subject, considering WHO is involved and how “trustworthy” they are toward the welfare of we-the-people!*]; Waco: Lessons learned; Crisis media management; Local agency interaction with the Department of Justice; So sue me: Legal Advice on areas of high liability; Avoiding civil liability when the abusive spouse is a police officer; The impact of urban crime on suburban and rural jurisdictions; Pro-active media strategy; Successful techniques for investigating/countering bias and hate crimes; Financial crimes; How to feature a fugitive on America’s Most Wanted; International policing: Thinking locally and acting globally, etc.

While entering the workshop on Bias and Hate Crimes, there was literature placed on the seats for those attending. The material consisted of: a photocopied newspaper article; a questionnaire/training guide concerning law enforcement’s response to hate crime; and then the primary tool, namely a thick, slick 40-page booklet titled, 1994 Hate Crimes Laws—A Comprehensive Guide [A publication of the Anti-Defamation League (A.D.L.)]. Among those mentioned in this seminar for investigations was what was referred to as “The White Patriot Party”. The FBI representative present stated that due to the 1st Amendment, current investigations in this particular area of “terrorism” are sparse and must be initiated by the Justice Department. There are currently only 26 ongoing investigations nationally. Hate crimes are pursued under Title 18, Sections 241, 245, 247, 248 and 42 USC 3631. There are currently 32 states which have passed hate crime legislation. Hate crimes were paralleled with “domestic terrorism”.

In another seminar on terrorism, some new and alarming definitions were put forth. These new definitions of terrorists include: **Skinheads**; **Tax Protestors**; the **Unorganized Militia**; and those opposed to NAFTA! No, that is not a misprint. Interestingly enough, these individual seminars were all tape recorded and tapes made available—all, that is, except this session and another on Waco: Lessons learned, and perhaps others now censored.

The seminar on financial crimes revealed the incredible progress made by law enforcement in the area of financial tracking. Specifically, FinCEN (Financial Crimes Enforcement Network) has been assigned a central role for the Treasury Department. The tentacles of FinCEN were clearly outlined with charts on the overhead projector—put in place and removed so quickly as to barely register in the mind. These charts were “*eyes only*” and included Project Gateway among others. I can say that the charts reflected an elaborate relationship with all confidential banking institutions, Interpol, various national and international agencies including any and all data-bases on any given individual. This linkage can be with all master computer systems and the appearance of its effectiveness can only be described by one word: awesome.

With thousands of Police Chiefs, FBI, Secret Service, Justice Department and other representatives present, one thing was abundantly clear: These were and are men of integrity, honor, and bravery—they only lack one thing, knowledge. When asked point-blank: Do you know about Executive Order 12919 and its transferring of authority to FEMA, invariably the law enforcement representative asked had never heard of it. These well meaning, well-trained men and women, quite simply, do not have all of the information about what is taking place and what they are involved in implementing. And how could they become fully informed in a system designed to inform only on a “need to know basis”.

So what have we here? We have an open “locking-down” of the New World Order plans for total control. *We the people* are not part of the Elite’s plans except as subservient to their wishes. Oaths of loyalty to the Constitution are fine when those taking the oath understand their meaning, but when the officers involved do not know the *4th Amendment [the right to privacy and security against unreasonable searches and seizures; search warrants]* from the *7th Amendment [right to trial by jury]*—we’ve got some real problems.

CALIFORNIA TO LOSE MILLIONS UNDER NEW CRIME BILL

DO YOU LIVE IN A DEMOCRACY OR A REPUBLIC?

Editor's note: We wonder if Senator Rogers may be a closet reader of CONTACT when the following excellent newsletter of his appears so soon after our outlay on this important subject. See p.3 of the 9/20/94 issue of CONTACT.

This is a question that will often provoke a variety of answers, depending on whom you ask. Many just assume that we live in a democracy and that our form of government is democratic. And yet many students of political organization state strongly that we were formed as a republic and remain one to this day. Does it make any difference which term is used? For many readers this may be only a matter of words; many others will say that it makes a lot of difference.

The term democracy means rule by the people, while the term republic, as pointed out by John Adams in 1775, means "a government of laws and not of men" requiring that both the people and their rulers obey these laws. An assembly of representatives chosen directly or indirectly may be called a council, a legislature, or a congress.

The origins of republics go back to the Greece of the Sixth Century, B.C. The city of Athens was suffering from upset and turmoil, so a distinguished citizen named Solon was chosen to bring order. He established a series of laws that enabled the citizens of Athens to govern themselves. He established government by written and permanent law in place of government by changeable decrees. Unfortunately, over several centuries the enforcement fell to a succession of tyrants, so a true republican form of government was never achieved.

It was the Romans who in 454 B.C. established the beginnings of a republic when the **The Twelve Tables** were adopted. These were laws based on Solon's laws, and became the written constitution of the Roman Republic. **The Twelve Tables**, amended over time, remained for some nine hundred years the basic law of Rome. The Romans themselves referred to their form of government as having a "mixed constitution." By that term they meant that it had some elements of a democracy but that the interest of all of the various classes of Roman society were taken into consideration by the Roman constitutional government, not just the interests of one class. The Romans were opposed to tyranny in any form, and to guard against it they set up an elaborate system of checks and balances. Does that sound familiar? It should, because that is exactly what our country's founders did when they crafted our present Constitution. And like the Romans before, our Bill of Rights protect the people from their own government. Sad to say, the first ten amendments to the *U.S. Constitution* have been attacked over the years by those who have partisan issues to push, but they

remain strong if we understand and defend them.

Cicero said about the man usually chosen as leader by an ungoverned populace as “someone bold and unscrupulous... who curries favor with the people by giving them other men’s property”. When our Founding Fathers established a “republic” in the hope that we could keep it, they were well aware to what term they were using. Nowhere in our *U.S. Constitution* does the word “democracy” appear, and that omission was deliberate. In addition, none of the constitutions of our fifty states contain the word democracy.

Section 4 of Article IV of the U.S. Constitution specifically states:

“The United States shall guarantee to every state in this union a **republican form of government**, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence”.

In a speech in 1788 Alexander Hamilton said: “It had been observed that a pure democracy if it were practicable would be the most perfect government. Experience has proved that no position is more false than this. The ancient democracies in which the people themselves deliberated never possessed one good feature of government. Their very character was tyranny; their figure deformity.”

In 1928 the U.S. Army Training Manual gave the following quite accurate definition of a democracy: “A government of the masses. Authority derived through mass meetings or any form of direct expression. Results in mobocracy. Attitude toward property is communistic—negating property rights. Attitude toward law is that the will of the majority shall regulate, whether it be based upon deliberation or government by passion, prejudice, and impulse, without restraint or regard to consequences. Results in demagogism, license, agitation, discontent, anarchy”.

Yes, it **does** make a difference whether we call our form of government a democracy or a republic—it matters a lot. And remember, as we give the salute to our nation’s flag, we say together, “I pledge allegiance to the flag of the United States of America, and to the **republic** for which it stands, one nation under God, indivisible, with liberty and justice for all”. May it ever be so.

AN AFTERWORD: “TO UPHOLD AND DEFEND”

(Open Letter To Fellow Police Officers)

Editor’s note: The following excellent Afterward is extracted from the book, From My Cold Dead Fingers: Why America Needs Guns. Ordering information is at the end of this article.

This is dedicated to those brave men and women who have chosen to “protect and to serve” as their vocations in life. It is written with the hope that each peace officer will seriously reflect on his and her oath of office, and rededicate him or herself to the constitutional principles upon which our country was founded and of which all police have sworn an oath to defend.

After the Revolutionary War and the subsequent creation of the U.S. *Constitution*, attempts to protect our newly acquired liberties were established. Certain “guards” were put in place to ensure this protection for the people. Thus began the honorable station of police service.

“I do solemnly swear that I will faithfully discharge the duties of my office, and that I will uphold and defend the Constitution of the United States from all enemies, foreign and domestic, so help me God.” These, or similar, words are sworn by every police officer, public servant and government official in the entire United States. This oath carries with it a tremendous responsibility: to uphold and defend the principles of liberty for which hundreds of thousands of Americans have given their lives.

Yet, after the swearing-in ceremony, police academy graduates give little attention to the *Constitution*. Most police officers have never read the document they have sworn in the name of God to uphold and defend. Most police departments and academies provide no training whatsoever regarding the *Constitution*. They teach their trainees to read suspects the Miranda warning, and why police cannot kick in doors whenever they feel like it. But constitutional basics are seldom included in any kind of police training. If “ignorance of the law is no excuse” for civilians, then police officers had better get busy studying the Constitution.

It is necessary and vital that police learn survival techniques, case law, pursuit driving, marksmanship, and so on. However, none of these is more important than the officer keeping his or her oath of office. Police must be constantly reminded (yes, through police training) why they exist and what their constitutional responsibilities are. How in God’s name can basics be ignored and still full adherence to principles achieved? Police must be constitutional converts.

The precious rights secured in the U.S. *Constitution* have been entrusted to police for safekeeping. Police must never forget the time spent and the price paid to obtain our liberty. They can never relax the fervor with which it must be defended. How do “We the people of the United States...secure the blessings of liberty to ourselves and our posterity” without the nation’s police being dedicated to that end?

Today, police are being asked (or ordered) to enforce “laws” that clearly violate constitutional rights. Officers have been trained and inculcated to follow orders, and that police are not to interpret laws, just enforce them. That kind of military obedience has led in some cases to officers beating or shooting innocent people, confiscating property and homes, kicking in doors, writing citations with ridiculous “excessive fines”, and conducting background checks on law-abiding citizens who merely wish to own a gun.

No police officer, soldier, or any other government official should in any manner comply with an order that is unlawful or attempt to enforce a mandate that is unconstitutional. The U.S. Constitution is the supreme law of the land (Article VI, paragraph 2), and it supersedes all other legislation. Police officers and soldiers can be disciplined for insubordination when they have failed to obey a *lawful* order. If the order is proved to be unlawful or unconstitutional, however, the officer or soldier cannot be disciplined for failing to obey it. In the landmark case *Miranda Arizona*, Chief Justice Warren wrote: “Where rights secured by the *Constitution* are involved, there can be no rule making or legislation which would abrogate them”.

Theophilus Parsons, a Founding Father and former Chief Justice of the Massachusetts Supreme Court, wrote: “The people themselves have it in their power effectually to resist usurpation without being driven to an appeal to arms. An act of usurpation is not obligatory; it is not law and any man may be justified in its resistance”. Any citizen has the right to resist an unlawful arrest and no peace officer has a duty to make one.

Police “...and all executive and judicial officers both of the United States and of the several states, shall be bound by oath or affirmation to support this Constitution” (Article VI paragraph 3). *Law enforcement officers are required by the Constitution* to take an oath of office, and no authority exists to break that oath—not even an excuse like “following orders” of a superior.

Why would the Constitution require all police officers, all legislators, all elected officials and all public servants to swear an oath to “*defend the Constitution?*” The Founders intended that every level of government—those who make the laws, interpret the laws, enforce the laws—should have one common objective and primary purpose: to protect the individual and constitutional rights of each citizen. For that reason, every sheriff, chief of police and federal law enforcement administrator has a duty and responsibility to provide constitutional training to the officers in his or her department.

It’s worth noting that a major difference exists here between being supervised by someone and working for someone. A police officer is supervised by his sergeant, captain, sheriff, or chief, but every officer *works for the people*. A vast majority of Americans, and most police officers, want law and order. Together, then, the people and the police should be working to better understand the U.S. Constitution from its historical perspective.

There’s no room in police work for “teaching this jerk a lesson” or “showing that guy who’s boss”. It serves no purpose whatsoever for police to embroil themselves in power struggles with the public. In cases where it has happened, police spend more time saving face than saving lives. Pride is a luxury police can ill afford. It merely becomes a stumbling block in their mission to protect the

rights of the American people. But far too often, police officers and prosecutors become more concerned with “winning the case” than with truth and justice.

The people of the cities, towns and countrysides of America should be secure in the knowledge that the police will leave them alone if they have not broken the law or jeopardized the safety of others. The absence of unreasonable police harassment, checks and searches, is the right “to be secure in their persons, houses, papers and effects...” (Fourth Amendment). It’s a definition for “freedom”.

It is time “...this nation, under God, shall have a new birth of freedom...” (Abraham Lincoln, Gettysburg Address, 1863). It’s time for law enforcement officers to get back to the basics of law enforcement for which their jobs were created—preserving our Constitution.

Police have a difficult and thankless job. They put their lives on the line everyday in a world affected by drugs and violence and social decay. May each of us in this most noble profession, as we pursue the guilty among us, never be guilty ourselves of the greater crime: violating our oath in God’s name to defend the constitutional rights of the people we work for.

RECENT LETTER FROM MICHAEL MAHOLY

Dear Friends,

In the past few weeks, I have received many letters from concerned patriots from many different states. One of the most frequently asked questions is: What am I going to do when, and if, I get out of Federal prison?

After many sleepless nights spent wondering about this matter, I can only tell you that I truly do not know. The big question is “who” would consider, especially in today’s world, hiring a convicted drug and weapons smuggler. To perceive this question more clearly, and to understand this more, I ask you to put yourself in my position for just a moment. Now ask yourself, and be truthful: would you hire a felon?

Part of the purpose of sending a person to prison is not only to punish him, but also to demoralize him. They will not tell you this, but after they take everything one has, except for the very basics, they make things hard for you in the future. In my case, the government has spent hundreds of thousands of dollars training me for various tasks, but as I would find out later, the amount spent was a drop in the bucket compared to what I made for the masters of the game. So I am still considered a threat to them because of the knowledge I contain.

You can bet that, upon my release, I will be monitored very, very closely, until they, the people of the secret Elite, decide that they have had enough of my turn-coating and telling of their secrets. We all know that these people in power will stop at nothing to maintain their positions of wealth and power.

Perhaps I have already been a victim of some sort of inside government conspiracy “ordered” from someone in Washington, D.C. to, let’s say, make things on the inside of the prison system “hard” for Mr. Maholy—things like inadequate medical attention, such as my recent bout with kidney stones. I received over 34 injections of “stateall” and I have yet to get a straight answer as to what this medicine is. I was told to return to my cell and bear the tremendous pain, without even an x-ray for 2 weeks. I am not saying that there is a plan to destroy me from within; I am saying I would not be surprised at any tactics used by these people, and I have learned not to rule out anything, especially in the shadows of government.

My release date is in July of 1999, unless I can find an attorney to file certain motions which would change the date to March 1, 1995. I know little about law, as I never had been arrested before. I have written to several lawyers and inquired about their services and fees, to pick-up where my so-called “fantastic lawyer” left off. With the complexity and past events that led to my arrest, the lowest fee I was quoted was \$35,000. Since time is running out fast for the appeal process, and I

really have no way to raise these types of funds, I realize that I must accept the worst: that I will remain in prison until the year 1999.

I will continue to expose the corrupt people that I “know” are the big fish in the pond responsible for selling drugs and weapons to Americans and countries abroad. I have had offers from two different authors to write a book about my experiences running drugs and weapons for the C.I.A.; however, I cannot write any material until I am released from prison and off of “paper” with the justice system.

I am limited as to what I can tell in here, as “most” of the various items and data that I would like to share with you are censored and kept. It will never be released until I am free from these chains that bind me. In fact, this letter is photo-copied and may, itself, not reach you.

As you may know, I am a new researcher for the CONTACT. I truly had never heard of this very informative newspaper until someone whom I had never met before, took it upon herself to write to me and offer her understanding, trust, help, and the love of a true friend. This woman, who has been a patriot of this country for over half a century, was responsible for getting my story printed. I have never seen her—or you—but by your human understanding and compassion and your will to reach out and help forgive my sins against the people, you have been supportive of me in my problems, while I am sure you have problems of your own.

I am not as popular as Mr. Jackson or Gunther Russbacher, I am just an insider who went down. I receive nowhere near the amount of mail these people do. I want you to know that I am grateful for what mail I do receive and, also, please do not think for one minute that I am up to the same tactics that some others may be up to. I prefer not to do any name-calling, as it is not my style, but I think we all can read between the lines, can’t we?!

If any of you think that, perhaps, you know of someone who would be interested in offering me some type of employment, or you, yourself, have some work that I might be able to do upon my release, please let me know. It might be a little early to think of such things, but it is questions like this that I lay awake nights thinking about. It is hard for me to explain how this bothers me. I guess it’s an insecurity of mine, not knowing what will become of me, where I can go, or what I will even eat. I have nowhere to go. There is no work I am afraid of, and I can learn anything. All I need is a chance to prove myself.

So, please, if you have any ideas or suggestions for me, please tell me. I truly have repented for my sins, and never plan to do the things I have done. I now see the light that I have never seen before. If any of you reading this have been in the state of mind I am in—confused, mixed-up, almost lost, then maybe you can share your thoughts and views with me. I can use any and all the advice I can get.

Thank you for your time, once again, and please continue to write. I promise to answer you as soon as I can.

BROKEN TREATIES PROMPT U.N. INDIAN FORUM REGIONAL TRIBES TO HAVE THEIR SAY

Native Americans are as mad as hell the U.S. has broken every one of the 400-plus treaties, and they're not taking it any more.

Instead, they're taking it to the United Nations some time in 1995.

Miguel Alfonzo Martinez, a U.N. representative, is traveling to eight sites nationwide to hear testimony.

One stop on the U.N.-commissioned study is in Seattle, where he will lead an open forum from 9 a.m. to 5:30 p.m. tomorrow and 9 to 6 p.m. Tuesday at Daybreak Star Cultural Center in Discovery park.

Dozens of Native people from the Northwest states, Alaska, Montana and Utah, are expected to give presentations on issues ranging from fishing rights to tribal recognition.

Members of as many as 20 "unofficial" tribes in Washington may be denied rights enjoyed by tribes the government recognizes.

Tomorrow's "Nations to Nations" event also features a 5:30 p.m. salmon dinner followed by a 7 p.m. reception. The public is welcome (information: 781-5677).

"We are gathering information to take to the U.N. so we can have these issues addressed in the world court," said David Hamilton, an activist for Native-American rights. "We want to hear what the world thinks of these practices, when the U.S. is going into other countries and saying, 'We're gonna make sure you treat your people right.'"

Native-American leaders attending this workshop include activist Russell Means, treaty council project director Bill Simmons, and tribal officials Bill Frank, Jr., Jewell James, Johnny Jackson and others.

Hamilton said, "the issues we're dealing with go back as far as (the Treaty of 1855), and some go back farther than that. I have a 30-page list of treaties that were not honored."

In 1989, the U.N. commissioned a study to document and investigate the history and legal status of treaties and other agreements made between indigenous peoples and colonial governments. This is the last year for submitting data.

Workshops have been held in New York City, Rapid City, Minneapolis and Albuquerque. Others are set for San Francisco, Tucson and Oklahoma State University

LEGACY IN LIMBO
INDIAN ELDERS STRUGGLE TO SAVE,
PASS ON TRADITIONS

From an article appearing in the September 25, 1994 Albuquerque Journal—(quoting:)

At a nursing home on the high desert mesas west of Albuquerque, Laguna Pueblo Indians are engaged in an experiment to create a place that reflects the closely-knit tribal community and its spiritual values.

In North Carolina, Cherokee elder Walker Calhoun has mined his own memory to bring back songs, dances and sacred traditions that were once in danger of being lost. Now he's passing them on to the tribal young.

The two cases point up the contradictions facing Native Americans: Across the country, Indian elders are struggling to preserve and impart tribal knowledge and wisdom to a younger generation that sometimes isn't listening.

Yet even as they try to preserve their traditions, their tribal wisdom is suggesting new approaches to longstanding social problems confronting society at large—the same society that has helped erode Native American culture.

Native religions, for example, have animated new spiritual initiatives and helped heighten general awareness about the need to preserve the environment.

And the Laguna Rainbow Nursing Home demonstrates how Indian community values could help nursing homes everywhere to find ways to humanize their notoriously isolated environments.

At the home, Santiago Thomas, 95, of Laguna Pueblo, goes out into the dusty courtyard each morning and prays to his gods, scattering cornmeal on the ground.

The Rainbow has a program for teen-age Lagunas to work in the home, arranges regular visits by children and offers diets of traditional Indian foods. Time is allotted for prayer, with aides who speak the Laguna language furthering the process of humanization.

“They're cradled in their tribal structure,” said Laguna Rainbow director Theresa Biscardis.

For keepers of Native American traditions, the first challenge often is to preserve them for their

own people. When Walker Calhoun does the Bear Dance, stirring hickory leaves to find acorns, playfully clawing a mate, he is no longer a 76-year-old man remembering the past. He is the bear.

At his home deep in the Great Smoky Mountains of North Carolina, on the land where he was born, Calhoun honors the spirit of the bear—and of the Cherokee people.

Despite centuries of relentless invasions by outsiders, the bears still exist, as do the mountains and the Cherokee, and their spirits are still connected. But the connection would have been lost except for Calhoun's remembering the way it was celebrated through song and dance.

Calhoun, his face deeply lined beneath a sheaf of gray hair, black eyes averted, tells his own story.

He is a shy man who did not come easily to the position of elder or spiritual leader. As a nephew of the great shaman Will West Long, Calhoun's boyhood was spent learning traditional songs and dancing. He didn't know then that he was storing his uncle's songs and secrets for posterity.

"The preachers go against the stomp dance," he explained, as he sat on his porch whittling a blow-gun dart. "When the preachers heard the stomp dance was Cherokee religion, they went against it."

So fewer dances were performed, fewer children learned the traditions.

Then about 10 years ago, Calhoun said, "I noticed everything was going out of style. I tried to bring some back, you know?" He taught the tribal songs and dances to school children, including his own grandchildren, who now perform regularly at powwows and festivals.

In 1838-39, the Cherokee were brutally herded by the U.S. Army in forced marches from the Eastern United States to Oklahoma on what would be known as the Trail of Tears. A small band stayed behind, hiding in the Great Smokies, splitting the Cherokee Nation into Eastern and Western Bands. The tribe's spiritual and cultural center migrated west.

But in 1988 the centerpiece of its religion, the "spiritual fire," was returned to the Great Smokies near the Oconaluftee River. Around a dirt mound with a fire on top, Walker Calhoun helps his people, young and old, worship the Great Creator and practice their sacred ways.

The transmission of culture does not always meet with favor among the young. In some cases, the power of English, and the lure of MTV and pop culture, simply sweeps Indian culture before it like a flash flood in the desert.

Moreover, some young people learn the form but not the meaning behind their traditions. Said Agnes Dill, 81, an Isleta Indian who lives south of Albuquerque: "I see them practicing parts of the dances and ceremonies, but forgetting the exact significance of the activities. Every movement has some significance, but they don't know these things. For them now a lot of it is showmanship.

While tradition falters in some tribes, and assaults by the dominant culture persist, Native American ways continue to survive—and Native American values increasingly influence the larger so-

ciety.

Native American spiritual ideas are central to many New Age religious practices, whose adherents now number in the millions. Indian sacred places such as Mount Shasta in California and the area around Taos have become meccas for practitioners of New Age spirituality.

The environmental movement also owes a great debt to Native Americans. Vice President Al Gore acknowledges this in his book, *Earth in Balance*, when he quotes passages attributed to Chief Seattle in 1855.

“How can you buy or sell the sky? The land?” the chief said in response to an offer by President Franklin Pierce. “If we sell you our land, remember that the air is precious to us, that the air shares its spirit with all the life it supports.”

M-11 MISSILE ACCORD

In an article from the Oct. 5 edition of *THE WALL STREET JOURNAL*, written by Robert S. Greenberger, [quoting:]

China agreed not to export certain surface-to-surface missile technology to Pakistan, and in return, the U.S. said it will remove sanctions it imposed on Beijing last year.

At the same time, China agreed to hold discussions with the U.S. about export guidelines under the Missile Technology Control Regime, which is designed to limit missile proliferation. “Our goal is to get them into the regime,” said a senior U.S. official. China had pledged in 1992 to abide by the terms of the international accord.

The agreement announced yesterday removes an irritant to the U.S.-China relationship that began in August 1993, when the Clinton Administration announced it had evidence that Beijing exported M-11 missile technology to Pakistan.

U.S. officials said that yesterday’s agreement—signed by Secretary of State Warren Christopher [A5] and his Chinese counterpart, Qian Qichen, who is here on a visit—is one of the fruits of the administration’s policy to engage more fully with China on a wide variety of issues.

U.S. & CHINA

In an article from the Oct. 19 edition of *THE WALL STREET JOURNAL*, written by Kathy Chen, [quoting:]

U.S. relations with China have come a long way since they were traumatized by Beijing’s June 1989 crackdown on the democracy movement at Tiananmen Square. The latest proof is the current visit to China by Defense Secretary William Perry, during which he has vigorously promoted cooperation between the U.S. defense industry and Chinese companies with links to the very military that did the shooting at Tiananmen.

Mr. Perry’s four-day trip to China, ending today, marks a final step in normalizing ties. Strategic concerns may have topped the agenda of the visit, but trade considerations provided its underlying theme. Even as the two governments seek to rebuild a spirit of cooperation on vital military issues, U.S. companies have their fingers crossed that a business bonanza will spring from Mr. Perry’s tour.

CHINA’S POVERTY

In an article from the Oct. 18 edition of *THE WALL STREET JOURNAL*, [quoting:]

China, in an ambitious effort to curb poverty by the end of this decade, will hand out billions of dollars in aid to poor areas and cut off financial help to developed provinces, the CHINA DAILY said.

The government plans to infuse impoverished counties with \$1.17 billion a year in subsidies and loans. Of the country's 1.2 billion people, it said 80 million live in abject poverty. Western and Chinese economists say this is far understated.

China's unleashing of market forces in the past 15 years invigorated parts of the economy and produced a wealthy class but widened the gap with the have-nots. The government intends to better the lot of the poor by raising their wages and improving their education, vocational training, living standards and health.

U.S. & RUSSIA

In an article from the Sept. 29 edition of *THE WALL STREET JOURNAL*, written by Robert S. Greenberger, [quoting:]

The U.S. and Russia used their two-day summit to accelerate the cleanup of Cold War-era issues such as nuclear arms control, and to begin focusing on future prospects for business relationships.

President Clinton announced at a joint news conference with Russian President Boris Yeltsin that the two leaders agreed to begin dismantling thousands of nuclear warheads as soon as previously negotiated nuclear arms-reduction pacts are in force. Under Start II, the strategic arms reduction treaty signed last year, the two countries could take up to nine years to scrap the warheads; Mr. Yeltsin estimated that yesterday's agreement could reduce the time by seven years.

U.S. & NORTH KOREA

In an article from the Oct. 18 edition of *THE WALL STREET JOURNAL*, [quoting:]

The U.S., North Korea reached an accord to end a nuclear dispute.

The framework agreement, announced in Geneva, is designed to end Pyongyang's nuclear-arms program in exchange for diplomatic and economic benefits from the West.

The U.S. wants to focus on future containment rather than to insist that Pyongyang give up any existing weapons.

THE SPHINX

In an article from the Oct. 8 edition of *THE ORLANDO SENTINEL*, GIZA PLATEAU, Egypt—

[quoting:]

Workers repairing the ailing Sphinx have discovered an ancient passage leading deep into the body of the mysterious statue crouched at the foot of the Giza pyramids.

That the tunnel is old—very old—is not in dispute, said Giza antiquities chief Zahi Hawass. Evidence indicates it dates from pharaonic times.

What’s puzzling is who built the passage? Why? And where does it lead?

GATT LOSES

In an article from the August 1994 edition of FIN INTELLIGENCE REPORT, written by Pratap Chatterjee, [quoting:]

A British billionaire-businessman-turned-activist has criticized the General Agreement on Tariffs and Trade, saying it may cause two billion people to lose their jobs and land.

Sir James Goldsmith [A6], who made his billion dollars from gold mining and as a corporate raider, visited Washington to urge the U.S. Congress to vote against ratifying the General Agreement on Tariff and Trade (GATT).

“Some of the winners will be those with capital—people like me who will get a bigger share of this slice. But is it like winning a hand at poker on the Titanic,” Goldsmith said.

GOD’S EQUAL PARTNER

In an article from the Oct. 11 edition of the JOHNSON CITY PRESS, written by Vern Anderson, [quoting:]

A Mormon feminist who wrote that God has a woman as an equal partner in heaven faces ecclesiastical discipline in the first such case since the selection of a new church president raised hopes of a truce with the faith’s critics.

Janice Allred could be excommunicated at a disciplinary hearing Wednesday before her local church board and believes an essay she published in an independent journal is to blame.

“I don’t see it simply as an issue of being able to publish one article. It’s an issue of freedom to speak and write,” she said. [*Of course.*]

ABC’S RELIGION REPORTER

In an article from the Oct. 1 edition of *THE MODESTO BEE*, written by Julia Prodis, [quoting:]

Peggy Wehmeyer was just a fledgling TV reporter filing routine stories on Texas train wrecks and

homicides when she established a reputation as a breed part.

“They send me on spot news, I come back with God,” she said.

It was 13 years ago that she first put a spiritual spin on a new story—a mother’s faith after her son’s death, a plane crash survivor’s questions of mortality.

Now, Wehmeyer, a devout Christian herself, is ABC’s religion reporter—the only religion correspondent in network television.

“I’m not the religion police. I’m a journalist,” she responds. “I have no agenda or need to convince people that my view of the world is correct. If you’re a good journalist—whether you’re an atheist, a born-again Christian, a Muslim or a Jew, you should be able to cover religion well. And I would say that someone who has faith has a good chance of doing it well.”

GOD & CLINTON

In a column from the Aug. 21 edition of Southern California’s DAILY NEWS, Cal Thomas writes, [quoting:]

President Clinton claims God is on his side—a claim Democrats and liberals of his stripe have in the past criticized Republicans and conservatives for making.

In a talk to a mostly black church in Maryland last Sunday, the President said it is “the will of God” that Congress pass the Crime Bill. He didn’t say whether God would accept any amendments, so one is left to accept by faith that God supports the entire package. The Almighty apparently knows how to play political hardball. Hundreds came to Rosa Lopez’s house in Hollywood, FL on Thursday, Oct. 13, because Lopez believes the Virgin Mary speaks to her on the 13th day of every month. The South Florida pilgrims ignored a rock band and wise-cracking radio deejays, who were skeptical that they would find the vision they sought. Many spoke of seeing crosses in the sky and silhouettes of Mary. In Conyers, GA, on the same day about 30,000 gathered at a farm to see a vision of the Virgin. A woman spoke what she said was a message from the mother of Christ.

UNITED NATIONS ARMY?

In an article from the Sept. 30 edition of *THE MONTREAL GAZETTE*, written by Laura Eggertson, [quoting:]

Canada will study the creation of a standing army at the United Nations as part of a reform of the often-criticized world organization, Foreign Affairs Minister André Ouellet said yesterday.

“We believe that such an instrument is one that could reinforce the credibility and the efficiency of the United Nations,” Ouellet told reporters.

Canada will study the scope, size, make-up, command structure and costs of such a force and report back to the General Assembly next year, Ouellet said.

AUSTRALIA’S FOOD PRODUCTION

In an article from “down-under”, taken from the Sept. 29 edition of *THE COURIER-MAIL*, written by Brendan O’Malley, [quoting:]

Australia will reach the limits of its ability to export food by early next century, the Australian and New Zealand Association for the Advancement of Science conference at Deakin University in Geelong was told yesterday.

Prominent environment expert Dean Graetz, who heads CSIRO's wildlife and ecology division, said limits to Australia's food production would probably be reached by 2020.

Those limits could even have been exceeded by that time—with grave consequences for the nation's environment and prosperity.

“Contrary to widespread myth, Australia was not and cannot ever be the food bowl of the world, or even of Asia,” he said.

CIA BEHAVIOR

In an article from the Oct. 1 edition of *THE ORLANDO SENTINEL*, WASHINGTON—[quoting:]

The reckless personal habits of confessed turncoat Aldrich Ames did not raise suspicions inside the CIA for years because such behavior was not considered particularly unusual, a senior CIA official said.

Besides a drinking problem, Ames was known within the Central Intelligence Agency's clandestine service to be “oblivious to personal security,” the official said in secret testimony this week to the Senate Intelligence Committee.

A copy of the testimony by Frederick Hitz, inspector general of the CIA, was released Friday. Hitz testified on the findings of his office's in-depth investigation of how Ames managed to escape notice as a spy for more than eight years.

Hitz said the explanation lay mainly in the culture of CIA management: a reluctance to believe that one of its own could be a traitor, and a “general distaste” for the assigned counterespionage duty of investigating agency employees.

Hitz said that Ames abused alcohol, carried incriminating documents in his checked airline bags, left classified files on a subway train and openly walked into the Soviet compound in Rome and the Soviet Embassy in Washington during his spying years.

“These deficiencies were observed by Ames's colleagues and supervisors and were tolerated by many who did not consider them highly unusual for Directorate of Operations officers on the ‘not going anywhere’ promotion track,” he said.

JAPAN'S MURAYAMA [A14]

In an article from the Oct. 3 edition of *THE WALL STREET JOURNAL*, written by Jathon Sapsford, TOKYO—[quoting:]

Prime Minister Tomiichi Murayama, addressing the first day of a special session of Parliament Friday, spoke to a half-empty chamber, a grim reminder of the uncertain state of Japan's political affairs.

HUNGARY'S APOLOGY

In an small article in the Oct. 5 edition of *THE ORLANDO SENTINEL*, NEW YORK—[quoting:]

Hungary apologized Tuesday for its role in the Holocaust and for persecuting Jews before the Nazis took over the country in 1944. In a statement read to a meeting of the World Jewish Congress, Hungarian Foreign Minister Lazlo Kovacs said: "The historical experience of 50 years is perhaps enough time for the Hungarian nation to face itself bravely and honestly, just as the Germans were the first to do immediately after the war." Jewish leaders hailed the statement.

U.S. TREASURY

In an article from the Oct. 20 edition of *THE WALL STREET JOURNAL*, [quoting:]

The Treasury plans to raise a combined \$12.83 billion in new cash next week with the sale of \$17.25 billion of two-year notes on Tuesday and \$11 billion of five-year notes Wednesday.

The balance of the proceeds will be used to redeem \$15.43 billion in maturing two-year and five-year notes.

TREASURE HUNT

In an article from the Oct. 4 edition of *THE WALL STREET JOURNAL*, [quoting:]

Rumors of hidden treasure in central Vietnam have prompted a rush of prospectors hoping to find a fortune in gold and precious stones. By one account, companies in Ho Chi Minh City years ago were supplied with a tiger skin inscribed with a family's history that mentioned a gold treasure in the jungle in Binh Thuan province near the La Nga River. The search there has sparked a legal battle over profit-sharing between two companies, a murder attempt and other problems for local authorities, and environmental damage as some failed prospectors capitalized on forest products instead.

HANTAVIRUS

In an article from the Oct. 13 edition of the *ALBUQUERQUE JOURNAL*, SALT LAKE CITY—[quoting:]

Health officials have identified two more Hantavirus cases in Utah, including one that dates back to **1959** and another that was fatal.

More than 85 cases have been reported nationwide. The disease has a mortality rate of about 54 percent.

EL NINO

In an article from the Oct. 10 edition of the *ALBUQUERQUE JOURNAL*, written by Kathy Sawyer of *THE WASHINGTON POST*, [quoting:]

A wave of heated water more than a decade old [*say what?*]*—a remnant of the most powerful El Nino event in this century—has been detected from space as it travels across the northwest Pacific Ocean.*

The wave may still be affecting weather in the region.

Oceanographers analyzing the data from the U.S.-French TOPEX-POSEIDON satellite expressed surprise. “The fact that we are seeing this wave 10 years later is an amazing discovery,” said Gregg Jacobs of the Naval Research Laboratory.

An El Nino begins when warm water builds up in the Pacific, near the equator, and moves eastward toward the coast of the Americas. This moving concentration, called a Kelvin Wave, is “reflected” off the coastline and moves back across the Pacific as a Rossby Wave.

The effects of the 1982-83 event were felt globally.

The researchers noticed the remnant wave while studying the satellite’s data on a current off the coast of Japan. They discovered the El Nino remnant wave was pushing the current northward, raising the temperature of the northwest Pacific.

CATTLE MUTILATIONS

In an article from the Sept. 20 edition of the ALBUQUERQUE JOURNAL, written by Fritz Thompson, [quoting:]

Mysterious cattle mutilations in northern New Mexico attracted federal attention Monday when Sen. Pete Domenici offered help to state brand inspectors, who say something other than predators is cutting up the livestock.

“We don’t know who’s doing it or why they’re doing it,” John Wortman, executive director of the New Mexico Livestock Board, said in a telephone interview. “But we know for sure it’s not predators.”

More than two dozen mutilations have been reported this summer, most of them near Taos, Chama and Raton, Wortman said.

Sex organs and often the anus have been removed in the mutilated cattle. Sometimes the tongue is gone.

“A couple of people have made a big deal about it being a cult or a UFO,” Wortman said, “But we have no evidence that it’s anything like that.”

He said the mutilation “might point to cult activity, but we’re not claiming that yet.”

He said there have been no signs of a struggle, and that the missing organs were removed “cleanly and precisely, with very little blood.”

HARVARD LAW PROFESSOR SAYS GATT IS
A TREATY, NEEDS TWO-THIRDS VOTE

WASHINGTON—A Harvard University law professor—disputed by a Yale University law professor—said Congress would violate the Constitution if it approved a new world trade accord with a simple majority vote of the House and Senate.

The accord, negotiated under the General Agreement on Tariffs and Trade, is a treaty and requires approval by two thirds of the Senate, Harvard Professor Laurence H. Tribe said Tuesday.

Tribe told the Senate Commerce, Science and Transportation Committee that he did not oppose the 123-nation, tariff-cutting agreement on its merits and that he generally supported the Clinton Administration.

But the document has all the characteristics of a treaty affecting U.S. sovereignty and not of a mere agreement, he said. The administration's contention that it's not a treaty "is simply mind-boggling," he said.

However, Yale Professor Bruce Ackerman said Tribe was reading the treaty provision of the *Constitution* "in a vacuum." The House and Senate can approve GATT as an agreement, falling short of a treaty, under another provision of the *Constitution* giving it the power to regulate commerce with foreign nations, he said.

He pointed out that both the North American Free Trade Agreement and the accord establishing the World Bank and the International Monetary Fund were approved as agreements, not treaties. If the Senate were to insist on treating GATT as a treaty, it would cast doubt on the legitimacy of U.S. participation in those organizations, he said.

The House and Senate are scheduled to vote on GATT in a lame-duck session the week after Thanksgiving. Under special fast-track rules for trade pacts, GATT cannot be amended and must be accepted or rejected by a majority vote in each chamber.

Meanwhile, consumer advocate Ralph Nader said the new World Trade Organization, created to enforce the accord, would be able to bring pressure on states and federal government to dilute laws protecting consumers and workers.

Trade disputes would be submitted to panels, whose decisions could allow other countries to impose sanctions on the United States and could be overturned only by unanimous consent of the World Trade Organization.

"GRANDMA WRITES RIGHTS"

October 14-21, 1994

Dear Rick and Readers,

THAT DEMON DEMOCRACY IS ALIVE AND WELL!! (October 14) Recently, as you all know, our illustrious leaders—those fearless creatures, in their infinite wisdom—chasing that infinite rainbow, the golden pot of "DEMOCRACY" (which is NOT EVEN WRITTEN INTO OUR CONSTITUTION)—gave away OUR SOCIAL SECURITY FUNDS to a private corporation!! Now **that** is DEMOCRACY at hard work!

Those newfangled "attorneys"—you know the ones—they are into "attornments". They like to give away to all them scutters what **don't** belong to 'em, taking it away from the guys who worked so hard to get it in the first place, and they used DEMOCRACY to do it.

CHAPTER 15

THE MONARCH PROJECT

Editor's note: We recently received the following fax providing an overview of a sinister project many of you are, by now, familiar with. However, we share this as a sobering reminder of the kinds of antics the crooks in high places have been up to for a long time.

Since the American Intelligence Service was changed from the OSS during World War II to the Central Intelligence Agency (CIA), there have been a number of secret operations, some so secret that the sitting President of the United States does not even know. The CIA has evolved into a self-governing entity, answering only to the World Government. The American Government is known to its own employees, to political leaders and common people that LYING is the official business and order of the day. Lies and disinformation are constantly released by the CIA, the State Department, the FBI and from the Oval office.

There has been a massive cover-up of American POWs from World War II and other wars, and denial about using American soldiers for research on chemical and bacteriological warfare. During the middle of March 1993 the Pentagon finally admitted to the truth in this matter, and released the information that 80,000 American soldiers were used during World War II to test poisonous gases. These men were forced to enter buildings where gas was released and then were tested to find out what result it had on their bodies and their ability to continue fighting. For years these military personnel have been denied medical help, since the Pentagon did not want to admit this gross injustice to American citizens. There were several projects that killed thousands of people, but the American government denied that these projects existed. Here are just two of them: Majestic-12 and the Jason Society.

During World War II the Japanese government had set up laboratories in Manchuria where they tested bacteria, viruses, and occult/torturing programming on Allied prisoners of war. The same activities took place in Nazi Germany. After the war the U.S. military retrieved all the research from the Japanese and brought it to the United States, where it later was given to the CIA. The German scientists were secretly brought to the United States with their research data banks and put to work for the CIA. These men should have been charged with war CRIMES, but instead the American Government protected them and gave them high-paying salaries. The Germans and the recruited Americans then began working to develop a program in the U.S. with the code name of MONARCH.

The basic theory of this program is that through immense torture and occult rituals, a person's personality can be split into at least 12 parts, and the handlers can then program a person under ritual occult hypnosis to perform anything that the handler wants. In this way the person's will can be circumvented and the person can be made to commit an act that normally would be against his will and morals. This has military value, since a man or woman can be trained to kill, without regard to his own safety and well being. A person can be programmed not to bleed, and if shot be able to function until the mission is fulfilled. This type of training is now common for the Navy

Seals, the Delta Force, the Army Rangers, Green Berets and a number of other clandestine groups not known to the public. A watered-down version of this program is used for survival training, that was used on all military personnel during the Vietnam War and after. Once the program was perfected, it became clear to the top brass of the CIA that the most suitable people to be in charge of this project would be SATANISTS. During the last 40 years the CIA has become a haven for Satan worshippers, who now have legal protection for their deadly rituals. In return for their services to the government, they are protected against local law enforcement, who might investigate ritual murder and child abuse in the community. The British have perfected their own research in this matter at their center in Tavistock House in London, England.

People who have been trained in this area display superhuman strength, can work and function for long hours during stress without being tired. They are totally loyal to their handlers and are willing to die for the cause that they champion. The most coveted candidates who the CIA is looking for are ABUSED CHILDREN. They are already traumatized and can be easily programmed into split personalities. Thus the Satanists have set up a network of Day Care Centers where children can be abused on a large scale. Having access to police records, the CIA will search out known pedophiles and use them in traumatizing children, who later are picked up by CIA operatives and taken to special camps for further training and programming. This will explain in part where some of the missing children in America have been taken. In earlier issues of *The Dove* we have published reports about the Franklin cover-up in Nebraska. This operation in Nebraska was part of project Monarch and some of the abused young children were taken to officials in high places in Washington, D.C., where they were sodomized, raped and tortured to satisfy the perverted desires of high government officials. There is a possibility that former President Jimmy Carter had been programmed to a lesser degree, in order to be able to better serve the World Government. Jimmy Carter had received treatment from Dr. Peter Bourn, who was connected with Tavistock House. Past presidents since Eisenhower have always released their medical records. Bill Clinton has refused to release his medical records, and will not give any explanation. It is very strange that both Bill Clinton and Al Gore were patients in a mental health clinic in the first half of 1992, while they at that time were running as candidates. The media did not report this.

Bill Clinton was also in the Voice Laboratory at the University of Arkansas late in 1992. And as a former Rhodes scholar and being out of the country for several years which included a trip to Moscow during the cold war when he was a student in England, there is a possibility that he has been recruited and undergone programming to give him more strength and stamina. I guess I fall into the category of “overseer” until we can move along far enough to allow for travel and attention to a singular topic. Perhaps it is better this way as I sense that as we go along I will be included in some of the more integrated activities. By “integrated” I refer to coordinated relationships with our “Command”. At present it is decided that we will be very selective in what we offer while we become acquainted.

BUCKLEY GREEN LIGHT

This focus is a full can of a zillion worms. You who have been close to ANY major shifting, honoring of debts, getting contract funds, etc., will realize that there are a myriad bad-seeds sprouting at every turn. As Commander Hatonn tells us, it is useless to throw stones at ANYONE, for each step must be taken to arrive at our destinations. I can far better appreciate the loads which have been carried by such as Rick Martin, Ed Young, and others present at the paper and working in other multitudes of differing slots in order to accomplish a mammoth task. I wanted to participate but I simply did not realize that each day would take me into a thousand scenarios and directions. I find it exciting, sometimes most dreary, and I’m fortunate to be “single” as no wife I’ve heard of would put up, long, with this life-style.

THE “GREENS” LEGAL CASES

There was a debilitating, for home-town attorneys, deposition session yesterday. George showed up for deposition AFTER he established that ones from Tehachapi had not come to this encounter. Commander Hatonn knew it would be that way and we are all getting a lot of confirmation as to the wisdom of listening to a higher resource than our own.

One of the more interesting things that George lied about was the “collateral” for his notes to the Institute. He said that there were ONLY TWO BOOKS in question. Now, readers, even I know that there were some 60 at the time of his taking them and holding them. However, he sat right there and said the only two volumes under question used for **collateral** were OPERATOR-OWNER MANUAL and PRE-FLIGHT INSTRUCTIONS. Interesting! I do see that pushing on the string to the “Controllers” is not the best mode of action because of outstanding laws on the books which must be rescinded and/or negated before transfers of funds CAN be made. As the laws are NOW structured—the assets belong to the United Nations! WE OF THE CITIZENRY—OF THE WORLD—ARE NOW SERFS OF THE UNITED NATIONS. That means that we are puppets for the Puppet Masters—and the Elite One Worlders. I find that that mostly is headed up by the Committee of 16. DESERT ADVENTURE THROUGH STAR WARS BASES
Are They Gearing Up For A New Enemy?

*For years, the testimony of articles about secret government bases, where exotic space weapons and U.S.-made saucers are built and tested were “off the record” or from “sources who cannot be named”. In early April, 1992, I set out in my Chevy Blazer to do my own “field reconnaissance” of governmental and military complexes related to Star Wars weapons development and interfacing with UFOs. I did this to establish for myself the reality of the government’s reported military response to the presence of UFOs; **THE REALITY TURNED OUT TO BE MUCH MORE STARTLING THAN WHAT I HAVE PREVIOUSLY SEEN IN PRINT.***

Theoretical weapons research at New Mexico’s Los Alamos National Laboratories and California’s Lawrence Livermore National Laboratories is translated into actual working models of high-tech weapons at Sandia National Laboratories, in Albuquerque, New Mexico and Tonopah Test Range in Nevada.

I headed for New Mexico’s Kirtland Air Force Base, located on the southeast edge of Albuquerque. This complex houses the Southwest Regional Office of the Department of Energy (DOE), Sandia National Laboratories (SNL), the Defense Nuclear Agency (DNA) and the Interservice Nuclear Weapons School, as well as DOE’s National Atomic Museum. To say that DOE and SNL keep a low profile is under-statement; while other federal agencies had long listings of even minor departments in the Albuquerque phone book, DOE and SNL **were not even listed.**

Armed with a free pass, which is offered to civilians who want to visit the National Atomic Museum or SNL’s Solar Research Power Tower, I entered the Kirtland complex through its main gate. I couldn’t help passing DOE, USAF, SNL or DNA facilities and weapon test sites on the way in or out.

Three flags flew over the roof of the Department of Energy Regional Headquarters: the U.S., the DOE and **AT&T!** Yes, AT&T’s horizontally-striped globe flew alongside because, according to public information officer Joann Pigg (Personal communication 4/20/92) “Sandia National Laboratories *is* AT&T”. It appears that AT&T is the corporation behind the application of physics research to Star Wars weapons!

Although the government likes to tout its nuclear safety record, there were contamination warning signs posted at its own headquarters. But, contaminated or not, the DOE is secured like a fortress with check-point guard posts. Before walking to the front door of the headquarters building, one must first go into a personnel entry cubicle, punch in a code, and then exit through another door.

Since I could not enter the lobby area of DOE or SNL headquarters, I traveled a quarter-mile further, to the National Atomic Museum (NAM). At Los Alamos and Sandia Labs, the nuclear physicists and military were so proud of their history of nuclear “achievements” that they proudly displayed information I had presumed was classified. (It still may be, elsewhere.) I found, for example, that the U.S. now has **hydrogen bombs downsized as small as RV propane tanks, that could easily fit in an Army duffel bag or bus terminal storage locker.** Even more amazing (in view of Lawrence Livermore Laboratories’ continuous assertion, “**we’re still working on containing nuclear fusion**”) was NAM’s revelation **that the U.S. has been producing controlled fu-**

sion—self-sustained, and contained by a hyperstrong magnetic field—since 1987! Lasers, which were once used to implode fissionable material, **now produce fusion**. An inexhaustible and rather compact energy source, I wondered if this was the power plant that created a gravity-defying craft (U.S. UFO) I had seen at Area 51 on the Nevada Test Range, earlier in my trip. Another NAM revelation with Star Wars weapons implications (and applications) was that SNL has achieved advanced particle acceleration energy capabilities that can deliver a 100 trillion-volt burst of ions using a lithium diode one inch thick.

Across the street, appropriately, from the National Atomic Museum is the Interservice Nuclear Weapons School, where members of all branches of the Armed Services can learn how to use nuclear weapons. This weapon category no longer includes only hydrogen bombs, but also Star Wars weaponry that uses nuclear fusion as its power source.

The immense sprawling complex of Sandia National Laboratories with its test ranges that extend south and east of DOE headquarters for more than one hundred square miles, takes up most of what is labeled “Kirtland Air Force Base”. SNL has project buildings every half-mile in every direction out to the horizon. **Activities identified by the signs include mostly weapons application research in nuclear, nuclear transport, magnetic, solar (yes, solar weapons!), electromagnetic pulse, laser and particle beam energy.** At the Solar Power Tower laboratory, SNL boasts a **heliostat (a solar collector-concentrator device) that can burn through 1-inch-thick hard metal plating in 26 SECONDS.**

But the *piece de resistance* of Star Wars weapons research application **was Project ARIES, the Advanced Research Electromagnetic Pulse (EMP) Simulator Site, where a two block-long device was built for the Defense Nuclear Agency by** Edgerton, Germhausen & Greer (EG&G).

The EG&G Corporation is involved (along with WACKENHUT Corporation) in security for Nevada’s Areas 51 and S-4, U.S. super-secret aerospace vehicle test centers (Personal communication with security officers at EG&G and at Wackenhut 03/14/92), in the “**black budget**” (Black Budget is a term used to describe secret funding of special military or other covert projects not identified in the Congressional budget.) weapons operations like Project ARIES, and in maintenance of various U.S. Government nuclear facilities (Wildfire magazine, 6:1, Spring 1992). The EMP weapon consists of a 1 1/2 block-long barrel horizontally supported on a wooden (nonconductive) trestle 25 feet high, connected to a two-story tower building, connected in turn to an immense electrical apparatus with huge arms and massive connecting cables that looks like a gigantic Van de Graaf generator. The long-rumored electromagnetic pulse weapon has been spotted at last! Using fusion power and engineered to 100 **trillion-volt** bursts, it could arguably **overpower even the most exotic extraterrestrial UFO technology.** [S: Forget that thought—from my reliable sources I am told we don’t have ANYTHING to “overpower” a tenth of the UFO (true alien) technology!!] Clearly it is overkill to defeat an incoming CIS (formerly USSR) ballistic missile, for which nuclear-tipped *Sprint* intercept missiles suffice.

While driving around trying to find my way back from the solar weapons lab, I encountered the Manzano Mountain Weapons Storage Facility, an entire tunneled mountain for high-security storage of various items, such as nuclear weapons. According to Timothy Good, in ABOVE TOP

SECRET (William Morrow, New York, 1983), UFOs retrieved by the military are also stored there. Manzano is surrounded by three, high, razor-tipped wire fences with bare-earth zones between, presumably with embedded motion sensors. Armed personnel in Jeeps constantly patrol the area. The security at Manzano was in high contrast to the sporadic-to-nonexistent security elsewhere at Sandia.

At the northern end of Manzano was Coyote Canyon Test Site, where extremely classified Air Force, DNA, DOE and SNL research takes place. At the entrance, a sign designated the Defender Challenge project. This area was where USAF personnel spotted a low-hovering UFO in 1979 (*Above Top Secret*). Using binoculars to peer partway into Coyote Canyon, I could see a huge, 20 foot-high, metallic sphere resting on the ground, that was sheltered from above by a flat, tin roof and surrounded by four support poles. Whatever the research at Coyote Canyon was, it had made water in the area unfit to drink or even to wash one's hands in. Because of off-limits signs, I did not enter Coyote Canyon nor any of the other high-security canyons, so I cannot report what was going on at these sites.

Farther west in New Mexico, I investigated the National Radio Astronomy Observatory (NRAO), whose Very Large Array consisted of 27 huge 82-foot-wide "receiving" dishes, on support towers that move on railroad tracks. Each was as tall as a 12-story building, and capable of being grouped into many different configurations. The dishes I saw were arrayed to form an inverted "T", with each arm stretching for one mile; the longest arm pointed due north.

The stated purpose of this facility was to collect "weak radio waves from celestial sources". To an outsider, this meant mapping the heavens by locating stars and energized gas fields in space that emitted electromagnetic (EM) radiation in the radio frequency [*band*]. However, as with other sites on this tour, NRAO was not an average observatory. Parked adjacent to headquarters was an Army truck and two ambulances with NRAO insignias. (The handful of astronomers who worked here must have had terrible occupational accident records!)

Further insight was provided by NASA Ames Research Center spokesperson Dr. Jill Tarter during a presentation at the University of California, in Davis, California on November 26, 1991. Dr. Tarter revealed that on October 12, 1992, the United States would announce it was turning on its radio telescopes to listen for intelligent transmissions from space. This announcement was timed to coincide with the 500th anniversary of Columbus' "discovery" of the New World. (*This did occur.*)

Wonderful, except that this is *disinformation*. Actually, the U.S. government had been funding and conducting the **Search for Extraterrestrial Intelligence (SETI)** for years (Howard Blum, *OUT THERE*, Simon & Shuster, New York, 1990). One could speculate that the purpose of this high-profile government announcement was to create an **EXCUSE** to reveal ET communications, and finally an open admission by the government of extraterrestrials. **[S: I would guess at this point that Hatonn would tell you good readers to go back and read that last bit AGAIN!]**

What was NOT speculation was the evidence I observed regarding the use of government NRAO dishes to transmit extremely POWERFUL signals *into* space; these dishes **were directed just above the low-north horizon.**

A clue came while I was having dinner at the Datil Restaurant. Seated next to four NRAO astronomers, I overheard one complain about trying to get time on a radio dish to do his research. While I was at NRAO ***all 27 dishes*** were pointed away from the main part of the sky, and directed instead toward a target above ***the low-north horizon***. A photo of NRAO displayed at their headquarters ***also*** showed all 27 dishes pointed at the same low-north horizon angle. Why was there such a persistent focus on one area of sky when there was such competition for time on the dishes? Another clue was the desolate location of NRAO on the San Augustin Plains, a quiet region deliberately chosen for its remoteness from city radio stations and other EM radiation.

I obtained the physical evidence as I left NRAO. About two miles from the Very Large Array, with both my FM and CB radios on, the most excruciatingly intense screeching sounds came out of one of the radios while simultaneously blanketing both. **[S: Doris tells me she hears that all the time and no longer thinks about it—just starts receiving and translating!]** My CB meter was farther into the red than I have ever seen it go before. The howling screeched for several minutes. I could not believe my ears. Wouldn't such powerful EM signals interfere with listening to delicate radio waves from space? I turned off the radios until I reached Pietown, 21 miles to the northwest, where, upon turning both radios on, I again heard the deafening screech. Mercifully, after about two minutes it stopped; both radios again functioned perfectly, sending and receiving. I have not heard that noise since.

It occurred to me then that NRAO is not only receiving signals from space, but also sending them! Given the rule that EM field strength diminishes algebraically with distance, the sending power from the NRAO dishes was extraordinary (to swamp the CB and FM frequencies at 21 miles), as befits a signal intended to penetrate into outer space.

The third piece of evidence was a report by researcher Thomas R. Adams: In the 1980s, a director of the NRAO let slip to a neighbor that one of the purposes of the NRAO was to communicate with extraterrestrials. (Personal communication with Thomas Adams, author of *The Choppers and the Choppers*, on Jan. 4, 1993.)

To whom is the government signaling, and why is the government lying about SETI?

At Pietown, New Mexico, an eye-blink of four houses and one boarded-up store, the government was supposed to be building an even larger radio telescope complex, the Very Large Baseline Array, which would connect and harness the reach of radio-telescopes from Hawaii to West Virginia, and from Puerto Rico to New Mexico. (NRAO Exhibit data, 1992.) This would create an antenna with a "dish size" equivalent to almost one-eighth of the globe. The Very Large Baseline Array was due to be completed in 1992, but I saw no radio telescopes at that time. The only construction I could find involved huge pipes (10 feet in diameter) being prepared for placement underground in some oversized tunnel. The project had no explanatory sign, so what was really going on at Pietown I cannot say.

Congressman Steven Schiff (New Mexico) and Senator Diane Feinstein (California) have ordered the GAO (Governmental Accounting Office), the Congressional investigative agency, to look

into the crash of a UFO near Roswell, New Mexico and its subsequent retrieval and cover-up by the military and intelligence community.

CONCLUSION

Since 1992, a shadow government has continued its secret development of space weapons in response to intelligent species visiting Earth from other star systems (in our name, with our tax dollars). In 1993, at Kirtland Air Force Base, USAF's Phillips Laboratory rushed to complete a contract for the development of a *trillion-watt* electromagnetic pulse weapon. Also in '93, the Russians offered to share with the United States their advances in deployment of a *plasmoid* space weapon. A plasmoid is an extremely high-energy concentrated force field that can tear anything apart. This incredible system directs two very powerful energy beams: one consists of electromagnetic energy in the microwave range; the other consists of intense laser energy. These beams converge in space at a designated target—something like a miniature hydrogen bomb inside the Superdome.

Obviously, these weapons are not in response to the now *passé* Soviet ballistic missile threat. What then is the explanation? The time has come for this administration to come clean with the American people about what Star Wars (a.k.a. BMDO [Ballistic Missile Defense Organization]) really is and what the government really knows about UFOs and their occupants.

If you Serve God—welcome aboard! *And I salute you for your wisdom in choices.*"

I prefer the "welcome aboard" so I think I'll attend my intent pretty closely—besides, I think I must have been waiting for this time in experience for God alone (& maybe me) knows.

SOLZHENITSYN [A16]

In an article from the Oct. 29 edition of *THE ORLANDO SENTINEL*, MOSCOW—[quoting:]

Alexander Solzhenitsyn thundered into Russian politics Friday with his first speech to parliament—a blistering attack on a post-Soviet life in which democracy remains just a dream.

Lawmakers greeted the gray-bearded writer warmly and applauded often early in his 50-minute speech. But applause grew sparse as he turned his ire on virtually every political current, from market reformers to Communists.

The 75-year-old writer, who crossed Russia by train this summer after 20 years in exile, cast himself Friday as a messenger from the suffering people—from “the soul of an ordinary man.” Solzhenitsyn ran through the painful changes that have accompanied Russia’s post-Soviet turn toward capitalism: crime, inflation, industrial decline, poor health, the dominance of the U.S. dollar.

“Throughout my travels around the country, the people have begged me to come to Moscow and tell the Duma and the president what has been piling up and is boiling in the soul of an ordinary man,” he said. “Russia is emerging from Communism on the most twisted, painful and awkward path.”

As Russia’s most famous living dissident and author, Solzhenitsyn had been seen by many as a potential political player and moral authority when he returned to Russia in May. But he has kept a low profile, appearing only occasionally on an interview show on national TV, always critical of the government.

RUSSIAN FARMERS

In an article from the Sept. 25 edition of *THE DENVER POST*, by NEW YORK TIMES writer Michael Specter, [quoting:]

The fevered days of autumn have descended heavily upon the farmers of Russia. An unusually cold summer stunted their crops and late rains nearly washed them away.

Now the frosts are only a few weeks off, and if they come any sooner the nation will suffer its worst harvest in three decades.

“A lot in our country depends on the weather this autumn,” Prime Minister Viktor S. Chernomyrdin told a German television reporter recently, voicing the common concern that a particularly poor

harvest will hasten the effects of an already visible farm crisis. “What happens in the fields also has its effect on the political climate.”

That has been true here for hundreds of years, of course. Almost nothing means more to Russians than bread, and debates about the annual grain harvest always herald the fall political season.

As a practical matter, Russia’s anemic harvest—estimates suggest that it will be less than 85 million tons, not nearly enough to feed the people—will hurt only the nation’s pride and its pocket-book. The United States has already agreed to ship some of its surplus to Russia again this year. Nobody will go hungry. [*Wanna bet?*]

But despite the frenetic pace of the fall harvests, production of meat, milk, grain and vegetables has slipped each year since 1989. Clearly, weather is not the only problem confronting Russia’s troubled farmers.

Suspended between the lumbering world of a collective farm system that ran solely on the whims of the state and the brutal necessities of the free market, no section of the struggling economy has foundered as badly as agriculture.

A year after President Boris N. Yeltsin issued a historic decree guaranteeing Russians the right to buy and sell private land, fewer than 5 percent of the nation’s 10 million agricultural workers own anything that could be described as a farm.

Government officials estimate that by the end of 1994 at least 30 percent of the farmers in Russia will be bankrupt...

THE DALAI LAMA

In an article from the Oct. 18 edition of the JOHNSON CITY PRESS, BEIJING—[quoting:]

Attempting to discourage worship of the Dalai Lama, the Chinese government has banned all photos of the exiled Tibetan leader.

The Tibet Information Network, a London-based human rights group, said Monday that police had seized photographs of the Dalai Lama from the main shopping area of the Tibetan capital, Lhasa.

CHINA’S MEDIA CONTROL

In an article from the Nov. 2 edition of *THE WALL STREET JOURNAL*, [quoting:]

China’s Communist Party, tightening its grip on the government-controlled media, formed a team of newspaper censors, the SOUTH CHINA MORNING POST of Hong Kong said. The censors, mostly senior or retired newspaper editors, will report to a senior party official about articles considered unpatriotic, negative or sensitive. The move was viewed as a way to ward off challenges to power upon the death of paramount leader Deng Xiaoping, rumored to be near death.

CHINA

In a brief article in the Oct. 27 edition of *THE ORLANDO SENTINEL*, BEIJING—[quoting:]

China will overtake the United States as the world's top investment destination by the end of this century and itself become an increasingly larger investor abroad, speakers told an international seminar Wednesday. Edward Chen of the University of Hong Kong said China in 1993 attracted \$26 billion in foreign direct investment, ranking second to the United States with \$32 billion and accounting for one-third of all such investment in developing countries.

EU COMMUNICATIONS REFORM

In an article from the same edition of *THE ORLANDO SENTINEL*, BRUSSELS, Belgium—[quoting:]

The European Union's executive body has agreed to press for a sweeping deregulation of the telecommunications industry in the 12 EU member nations. The plan was adopted Tuesday evening by the EU's 17-member executive commission. It seeks to phase out of state monopolies in telecommunications by Jan. 1, 1998. The nations agreed in June last year to end state monopolies on telephone service by 1998, with exemptions for countries with less-advanced systems. The commission's new proposal calls for the deregulation of services such as data transmission, mobile communications and corporate phone networks. The plan would also allow utility and cable television companies to offer telecommunications services by next year.

JACQUES SANTER [A7]

In an article from the Oct. 30 edition of *THE SUNDAY OREGONIAN*, LUXEMBOURG—[quoting:]

The new chief executive of the European Union [EU] assigned the 21 members of his team Saturday to their positions for the next five years, one of his most delicate tasks.

Jacques Santer risked an early split in the European Commission by naming Hans van den Broek of the Netherlands to the key post of relations with eastern Europe and the former Soviet Union.

The appointment rankled current EU trade czar Sir Leon Brittan, who had lobbied strongly for the job. Instead, Brittan was chosen for the post of relations with the United States, Japan and other industrial nations.

LOS ALAMOS

In an article from the Oct. 13 edition of the *ALBUQUERQUE JOURNAL*, [quoting:]

The Department of Energy has given Los Alamos National Laboratory the green light to build a \$43 million machine to simulate the pressures and temperatures inside an exploding nuclear bomb.

If Congress agrees, the machine would be completed by 1998.

The machine, called “Atlas,” can take a 4-inch piece of metal and zap it with what laboratory scientist Steve Younger described as a burst of energy equivalent, for an instant, to the electrical output of all the world’s power plants.

At that, it is not enough to simulate the tremendous pressure and heat that builds up during a nuclear bomb blast, said Mark Parsons, the laboratory’s Atlas project manager.

But it is close enough to help scientists understand the phenomena at work in the blast, Parsons said.

Atlas will help make up for shortcomings in laboratory scientists’ knowledge about aging nuclear weapons now that they are no longer permitted to conduct underground nuclear test blasts, Parson said.

Atlas is one of a number of projects for which the laboratory is trying to win support as an alternative to underground testing.

MEMORY CHIP

In an article from the Nov. 2 edition of *THE ORLANDO SENTINEL*, TOKYO—[quoting:]

Two Japanese electronics companies plan to announce technology for creating computer memories that hold a billion bits of information, spokesmen said Tuesday.

NEC Corp. and Hitachi Ltd. said they have developed a way to make one-gigabit dynamic random access memory chips that have enough capacity to hold the complete works of Shakespeare 16 times over.

Details will be given at the International Solid State Circuits Conference in San Francisco in February.

Makers of memory chips have come out with a new generation about once every three years, with the capacity of each generation four times as great as the last.

GENETICALLY ENGINEERED FOODS

In an article from the Nov. 3 edition of *THE RECORD*, ARLINGTON, Va.—[quoting:]

Seven more genetically engineered foods—five for people and two for animals—have passed a voluntary Food and Drug Administration safety inspection.

But scientists Wednesday questioned whether the FDA is scrutinizing emerging biotechnology foods closely enough.

“I am a little troubled,” Dr. Marion Nestle, an FDA adviser from New York University, told the agency. “It’s as if FDA scientists have accepted these very complicated assessments [of biotech safety] on face value.”

The FDA in the spring approved the nation’s first biotech food, Calgene Inc.’s Flavr-Savr tomato, which has a gene that allows it to ripen longer on the vine and still get to supermarkets without turning soft. Although the FDA does not require genetically altered food to undergo a full-scale safety review, Calgene requested one.

Now the agency has completed much more cursory safety inspections of seven other genetically altered plants...The seven include three more tomatoes. There is also a squash, a potato, cotton, and a soybean plant.

SONIC HEALING

In a tiny article appearing in the Oct. 13 edition of *THE MODESTO BEE*, WASHINGTON—[quoting:]

The Food and Drug Administration has approved a new device to help elderly Americans’ broken bones heal faster. The Sonic Accelerated Fracture Healing System uses low-intensity pulses of ultrasound on fractures in the lower leg and lower forearm. While clinical trials showed the device accelerated healing in all patients with these fractures, the elderly saw the most improvement, FDA officials said.

GRAIN GLUT

In an article from the Nov. 1 edition of *THE WALL STREET JOURNAL*, CHICAGO—[quoting:] A record grain harvest, which is fast becoming a glut, and plunging meat prices are slowing the rebound in the nation’s farm economy.

Some economists believe that roughly one-fifth of small hog farmers may soon exit from the business, because prices are the lowest in 14 years. “We are in for a big shakeout,” said Ron Plain, a University of Missouri livestock economist. “We might lose a lot of hog farmers.”

And things don’t look as good for the nation’s grain farmers anymore. The Agriculture Department has been raising its forecast of the U.S. corn and soybean harvest since July. **The price of corn, the nation’s biggest crop, is sinking to the lowest level in eight years.**

While many Midwest farmers needed big crops this year to recover from last year’s flood-ravaged season, the size of the harvest has become too large to support commodities prices.

The Agriculture Department has shaved about \$5 billion from its estimate of 1994 net farm income. The government now sees net farm income rising 13% to \$49 billion, give or take \$2 billion, instead of the 25% jump from 1993 results that it originally projected during the planting season.

Some farmers aren't rebounding at even that pace. "We are about holding even, that's all," said Ronald Bledsoe, whose Miami, Mo., farm was partly covered by sand after a levee broke on the flooded Missouri River last year.

For the U.S. economy, the meat and grain glut is helping the nation dodge an inflation bullet. The corn supply had fallen to its lowest level since 1976 by the time farmers began harvesting their crops this September. But thanks to ideal growing weather this year, U.S. corn farmers have nearly completed harvesting 9.6 billion bushels, 51% above last year's flood-ravaged crop. The U.S. soybean crop is coming in at 2.46 billion bushels, up 32% from last year.

AUSTRALIAN DROUGHT

In an article from the Oct. 29 edition of the JOHNSON CITY PRESS, KOOTINGAL, Australia—[quoting:]

Allan Ballantine strode across the dry rocky bed of the Cockburn River, pulled out a pocket knife and slit the throat of a dying sheep, another victim of the worst drought for generations.

"It's hard to kill your own animals. But they have to be taken out of their misery," said Ballantine, 40, one of thousands of farmers and ranchers on the brink of ruin after four years of virtually no rain.

Rotting carcasses and skeletons of sheep and cattle litter his 1,100-acre spread, 220 miles northwest of Sydney. Most days now Ballantine kills two or three animals too weak to go on.

Even in the good years Australia is the world's driest inhabited continent. But now it's so parched the country's normally bountiful agricultural sector is on its knees.

Almost all of New South Wales, Australia's most populous state, and much of neighboring Queensland have been officially declared a drought area. Food exports have been slashed and recovery from a long recession has slowed.

"It is the worst drought in living memory," said Primary Industries Minister Bob Collins. "It will take years for the worst hit areas to recover."

GULF WAR ILLNESS

In a tiny article appearing in the Oct. 21 edition of some newspaper, name not attached, [quoting:]

Preliminary results from a new survey have raised suspicions that the mysterious spate [*outbreak*] of illnesses that has afflicted more than 20,000 Persian Gulf War veterans since their return home may be contagious, Senate sources said yesterday. Responses from the first 400 of a planned 1,000

servicemen and women to be polled have found that some of the symptoms, known collectively as Gulf War Syndrome, have also affected 78 percent of their spouses and 25 percent of their children who were born before the 1991 operation, according to an aide to Sen. Donald Riegle, D-Mich.

LAPD IN COCAINE BUSINESS?

In an article appearing in the Oct. 24 edition of southern California's *DAILY NEWS*, [quoting:]

The Los Angeles Police Department is considering manufacturing its own rock cocaine to use as bait in catching dealers, officials say.

The head of the department's street-level narcotics investigations is taking a cue from Orange County, which has been secretly brewing up its own crack for use in undercover operations.

LAPD Capt. Bob Hansohn said he is preparing a proposal for LAPD Chief Willie Williams that could put some of his officers on the street dealing drugs much like police in Santa Ana. There, 350 people have been arrested during the past 18 months by undercover officers dealing county-made crack cocaine. [*We have come a long way, baby.*]

AMERICA'S POVERTY

In an article from the Oct. 7 edition of the CHICAGO SUN-TIMES, written by Randolf E. Schmid, [quoting:]

The number of Americans living in poverty climbed past 39 million last year, the most since 1961 and an unwelcome surprise in the second year after the end of a recession.

[*Reminder: These are figures they're admitting to!*]

Poverty in 1993 was defined as an income of \$14,763 for a family of four.

Other findings of the new poverty report included:

- * Children are 40 percent of the poor, but 27 percent of the total population.
- * If non-cash benefits such as food stamps, Medicare, Medicaid, public-housing and fringe benefits at work were counted as income, the poverty rate would fall to 12.1 percent.
- * Blacks had the highest poverty rate, at 33.1 percent, compared with 30.6 percent for Hispanics, 15.3 percent for Asians and Pacific Islanders and 12.2 percent for Whites.
- * Asians and Pacific Islanders had the highest median household income at \$38,347; followed by Whites, \$32,960; Hispanics, \$22,886; and Blacks, \$19,532.
- * About 39.7 million Americans lacked health insurance at some point in 1993 including 11.5

million of those living in poverty.

* Median earnings of women were 72 percent of what men earned in 1993, tying an all-time high.

RAPID COP HIRINGS

In an article from the Sept. 25 edition of *THE DENVER POST*, written by Clifford Krauss, [quoting:]

Anticipating thousands of new cops on their streets, city officials from across the country praised Congress for passing the \$30 billion anti-crime package. But even before President Clinton signed the bill, criminologists warned that while quick hiring of police officers could make a dent in crime, it could also lead to more police brutality and corruption.

In one city after another—New York, Washington, Miami, Philadelphia, Houston and Detroit—quick expansions of the police forces have led to careless screening and hasty training. Criminal justice experts say that the rush to hire contributed to an increase in incidents like high-speed traffic accidents during chases, perjury by police officers and sloppy handling of evidence—not to mention behavior that is outright criminal.

“All known cases of hiring unusually large numbers of police very quickly have been total disasters,” said Lawrence W. Sherman, a University of Maryland professor and chief criminologist for the Indianapolis police. “You tend to lower standards.”

POLICE CHECK PRESS

In an article from the Oct. 20 edition of *THE TORONTO STAR*, written by Nick Pron, [quoting:]

A plan by Metro police to do formal criminal checks on reporters before issuing press passes has come under fire from some media outlets.

The universal press pass, which would eventually cover forces in the Golden Horseshoe area of southern Ontario, requires reporters to sign a waiver allowing police to check into their backgrounds.

“We’re not trying to control the news or what reporters can say,” said Metro police Staff Sergeant John Sillaots, in charge of the plan. “It we’re going to let reporters closer to a crime scene than the general public we want to know who they are.”

The police have always quietly and routinely done criminal checks on reporters in the past before issuing the passes. Under recent guidelines set out in Ontario’s Information and Privacy Act, they now have to get permission before looking into the computerized data banks.

But officials with some media outlets think the practice of making the criminal checks is wrong, and should be stopped immediately.

“This smacks of excessiveness on the part of the police,” said Brian Cantley, who is in charge of editorial services for the Canadian Daily Newspaper Association. “I’m not sure if I understand their rationale for doing it. No matter what they say, it is a form of control.”

HAWKING COMMENTS

In a tiny article in the Sept. 18 edition of the CHICAGO TRIBUNE, KUALA LUMPUR, Malaysia—[quoting:]

If there is intelligent life on other planets, it hasn’t been smart enough to find us yet, Stephen Hawking says. Speaking to 3,500 people Friday, the famous physicist discounted suggestions that UFOs contain beings from outer space. “I think any visit by aliens would be much more obvious and probably also much more unpleasant,” said Hawking, a Cambridge University professor who speaks through a voice synthesizer because of a nerve disorder. But he said that doesn’t mean there’s no life on other planets. “I prefer [to believe],” he said, “there are other forms of intelligent life out there, but that we’ve been overlooked.”

ATF AGENTS FIRED

In an Associated Press story dated Oct. 29, [quoting:]

Two federal agents have been fired for their roles in leading the ill-fated raid on Branch Davidian cult leader David Koresh and about 100 of his followers. The Bureau of Alcohol, Tobacco and Firearms fired Charles Sarabyn and Phillip Chojnacki, both based in Houston, effective Friday, Chojnacki confirmed Saturday when called at his home.

The Treasury report said Sarabyn and Chojnacki disregarded warnings from an undercover agent that Koresh knew the raid was imminent. They also were accused of lying to investigators.

VATICAN & THE PLO

In an article from the Oct. 26 edition of *THE ORLANDO SENTINEL*, ROME—[quoting:]

Seeking broader influence in the Holy Land, the Vatican on Tuesday established a form of diplomatic relationship with the Palestine Liberation Organization to balance its ties with Israel.

But in setting up what it called “permanent and official” relations with the PLO, the Vatican withheld gestures that might have been deemed by Israel to constitute recognition of a Palestinian state.

A Vatican statement said senior officials from both sides decided Tuesday to “give the already long-existing and fruitful working contacts a permanent and official character.”

“These are not diplomatic relations as such, but they are stable and official relations,” said Joaquin Navarro-Valls, the Vatican spokesman. “It is a matter of having a permanent, official channel to continue and develop relations.”

DE BEERS CARTEL

In an article from the Oct. 31 edition of *THE WALL STREET JOURNAL*, written by Neil Behrmann, LONDON—[quoting:]

A diamond may be forever, but maybe not the international diamond cartel run by De Beers Centenary AG.

After six decades of dominance over world-wide diamond sales, the London-based Central Selling Organization (CSO), which De Beers controls, appears to be splintering under the pressures of a persistent market glut and a Russian rebellion within the ranks of its own producing members. (Swiss-based De Beers Centenary is itself controlled by South Africa's Oppenheimer family.) If De Beers fails to pacify the Russians, the cartel could crumble, triggering sharp cuts in gem prices and in diamond-mining profits.

Russia is the most serious threat right now, as it is the world's second-largest diamond producer after South Africa and a leading member of the CSO cartel. The Russian government is pushing aggressively to circumvent De Beers's grip and sell more of its gems directly on the open market. To raise much-needed hard currency, and challenge De Beers at the bargaining table, Russia has been leaking large quantities of rough, uncut diamonds onto the world market.

THE AMERICAN DOLLAR

In an article from the Nov. 7 edition of *THE WALL STREET JOURNAL*, written by Michael Sesit, [quoting:]

The Federal Reserve spent as much as \$2 billion trying to boost the dollar last week while the Treasury secretary made dollar-supportive remarks and even Germany's central-bank chief rooted for the dollar.

Guess what? The greenback still looks like a wet noodle.

Analysts are predicting it will stay that way in the wake of Friday's declines against the German mark and Japanese yen. The dollar, they say, won't be buoyant until the Fed gains more credibility as an inflation fighter and the Clinton administration persuades foreign investors that it seriously wants a strong currency.

New ADL Report Reveals Militias Preparing For War With U.S. Government

NEW YORK, Oct. 27, U.S. Newswire—Angry bands of gun-toting right-wing militants, calling themselves militias, are preaching armed resistance against the federal government. The issue most agitating them is gun control, according to a report released today by the Anti-Defamation League (ADL).

Armed and Dangerous: Militias Take Aim at the Federal Government, reveals evidence of activities of these paramilitary groups in at least 13 states. ADL discovered linkages among some of the groups, consisting largely of sharing propaganda materials and speakers.

"The militias' target is plainly the democratic process itself," said Abraham H. Foxman, ADL national director. "To be 'fed up' with government is one thing, to call for armed resistance is quite another. We are especially troubled, but not surprised that they are attracting racists and anti-Semites. We urge all Americans, conservative and liberal alike, to spurn them."

The report states that militia ideologues have embraced conspiracy fantasies and are "obsessed with the role of government in two recent events—the Branch Davidian confrontation in Waco and the Randy Weaver siege in Idaho—which they interpret as signs of impending tyranny." They are equally agitated by the Brady Law and the federal crime bill ban on 19 assault weapons.

Leaders include John Trochmann, who with his brother and nephew heads the Militia of Montana,

one of the most visible and extreme such groups in the country. The Trochmanns have been members of the Aryan Nations, an Idaho-based neo-Nazi organization that promotes anti-Semitism, white supremacy and the establishment of a white racist state. Expressing the group's attitude toward violence, John Trochmann is quoted as saying: "We don't want bloodshed. We want to use the ballot box and the jury box. We don't want to go to the cartridge box. But we will if we have to."

In North Carolina, the leader of Citizens for the Reinstatement of Constitutional Government, Albert Esposito, urges his members to amass caches of the "Four B's: Bibles, bullets, beans and bandages." Many members, the report states, own semiautomatic weapons, including AR-15s and AK-47s.

Militias calling themselves Patriots emerging across Colorado, are being led by Duncan Philp (sic?), who has been an adherent of the racist and anti-Semitic Christian Identity movement. The Patriots' propaganda claims the federal government has betrayed the people and the Constitution through laws regarding "home schooling, abortion, taxation, freedom of speech and religion, and gun control."

Another Colorado militia proponent, Stewart Webb, made a series of threatening anti-Semitic phone calls from the mid-1890s into the 1990s. In Florida, a militia handbook includes obsessively and anti-Semitic and anti-black publication.

Members of the Blue Ridge Hunt Club in Virginia were arrested for stockpiling illegal weapons. A draft newsletter described the group's intended reliance on terrorist tactics. The plans included a weapons heist from the National Guard Armory in Pulaski, VA, according to law enforcement authorities.

A rising star in the movement is Linda Thompson, an Indiana lawyer. She issued a call, later rescinded, for a march by militias on Washington to arrest and try for treason congressmen who supposedly failed to uphold their oath of office. Thompson was arrested this summer for blocking a bus load of supporters of President Clinton's health care plan. At the time police found her she was carrying two pistols and had an assault weapon in her vehicle with 295 rounds of ammunition.

Militia activity also has been observed in: Arizona, Idaho, Michigan, Missouri, New Hampshire, New Mexico and Ohio.

The ADL report concludes that the chief responsibility for confronting this problem rests with law enforcement. "Numerous states have legislation regarding paramilitary training on the books," said Foxman. "Some of these laws were based on model legislation initially drafted by ADL in the 1980s. We urge states that do not have such laws to pass them now."

"We recognize the right of all people to hold and promote their views," Foxman added, "but there is no right to use force or violence to impose ideas on others or to resist laws properly enacted."

The report was prepared by the Fact Finding Department of the ADL Civil Rights Division.

We left the store with the gun and everything my little guy would need to look, act, and even smell like a hunter. Packages under both arms, we stopped for a breather and a cold soft drink just across from the marine department. Well, before our lemonade was finished, I spied a boat, motor and trailer that would be icing on the cake. What the hell, I might as well do it now! By the time we left the huge sporting goods store, another \$7000 cash was well spent.

Well, it was well into the late afternoon, but the mall was just a mile away—time for some new clothes, TVs, VCRs, stereo equipment, and gifts for my friends and relatives. Out of the \$50,000 I left Arkansas with that morning, I had just \$10,000 left. So I stopped at Cox Medical Hospital on the way home and made a cash donation of \$6000 to the new children's wing, a burn victim unit that had just opened. That was the least I could do. How many people do you know that just shell out that kind of money on a whim?

My whole purpose in telling you about this day of shopping is to explain to all of you that I was once a giver, not a taker. I liked it when I made people happy. But all along, in the back of my mind, I knew that it was the devil's money I was spending. I had a hidden fear, one that I could not explain at the time, but now realize all too well. In fact the four wheeler that I bought for my son would,

several years later, almost claim his life, flipping over on him and causing massive head injuries and causing him to be flown by air medivac to the same children's intensive care unit at Cox Medical Hospital. You see, the Lord DOES work in mysterious ways. He can give in a second, and take away in a heart-beat. But more on this later. I have strayed away from the story just to try and show you people the REAL me.

I was at home for five more days before my handler in Langley called me. I was to receive, in code, details of the drug distribution to several high-profile people in my area in Arkansas. Russell Hebert would be flying the drugs north from Morgan City, Louisiana. The first person on the list that was to receive drugs from us was a man named Al Gaston. Gaston owns one of the largest fly-in fishing resorts in Arkansas. His resort, that sits on the banks of Arkansas' White River, just 6 miles north of Clinton's so-called "White Water" land development, has 142 private condos, 6 tennis courts, 2 swimming pools, a private landing air-strip, and a 5-star restaurant that overlooks the world famous trophy trout-river, an operation worth millions. It is widely known by many prominent people of the state, that this is where Bill Clinton would fly for nights (even weekends) of extra-marital affairs with several of the women he dated, the same women Hillary would have to taste on the lips of her lying husband. Women like Jennifer Flowers and Donna Canton would regularly bed the man who had a strong hold on the state.

During this delivery, Gaston would host a special guest from Washington, D.C., a man dubbed by many as the Washington Drug Czar, Edwin Meese. Hebert would land his plane at the resort this time, just four miles from my home. I would drive down to the resort on the river and meet him at his condo that Gaston had reserved for Hebert. There would be three more people joining us from Little Rock: Bill and Roger Clinton and a man whose son is now a state senator of Arkansas, Oscar Luff. Luff owned three or four thousand acres of land in several counties throughout North Arkansas. Luff was instrumental in obtaining Clinton's "White Water" property. Luff and Vincent Foster had strong ties. Many under-the-table pay-offs were made by Luff to Foster and Clinton to secure Luff's son's future in the Senate.

As it turned out, Edwin Meese was also flying to Arkansas for a hidden operation. The mission was to be called Operation Green Bush, which, through the help of state and local law enforcement agencies and several National Guard units, Clinton would call for the eradication of much of the state's highly potent marijuana crops that dotted the steep ravines and mountain benches of northern Arkansas.

Hebert, myself, the two Clintons, Bill and Roger, and Oscar Luff would go to the lounge for drinks at Gaston's private club. Right away Roger asked Hebert if he had the cocaine and if he could get a taste, a "bump" of the white powder right away. Hebert laughed and told Bill Clinton that his younger brother Roger was a pain in the ass. Bill Clinton told Roger to wait awhile and to not bother the two C.I.A. operatives. Oscar Luff, an out-spoken German, stated, "Let's get down to business."

The five of us went back to the condo and split up the forty kilos of cocaine. Bill Clinton left with Al Gaston and Edwin Meese. Roger Clinton stayed and snorted cocaine until the blood vessels in his nose broke, releasing a steady flow of blood onto his thousand-dollar suit.

I never saw Bill Clinton the rest of the night. However, Edwin Meese came back an hour later and invited Hebert and me to ride along in the air convoy of National Guard helicopters, 6 of them in all, that would comb the ridges of nearby Madison County along the Buffalo National River, where it was suspected that a lot of high quality marijuana was being cultivated. Meese invited me to ride along with him in the Huey helicopter that would lead and also act as the air-to-ground command center. But a last minute decision made at the request of a D.E.A. agent, had me flying in chopper number 3. My lucky day!

As we entered the National Forest boundaries, a well-coordinated air-to-ground raid was about to begin on some already-spotted marijuana patches, some containing as many as 500 plants, each with a street value of as much as \$1000 each. As the choppers cut through the dense fog of the Ozark Mountains, things started to heat up fast. At a height of about 100 feet, while hovering over a patch of marijuana, a pot grower shot up from one of the pig trails that they used along the cane bottoms of the Buffalo River. The 30-06 bullet ripped through the bottom of chopper number 1 and struck the D.E.A. agent in the left hip. The bullet hit him high in the hip, passed through the agent, and lodged in the headrest of Edwin Meese's seat. If the D.E.A. agent had not caught the bullet himself in the hip, it would have surely struck Edwin Meese, likely fatally.

This incident made national headlines. The shooter was shot four times from return automatic fire from D.E.A. agents in the pursuing chopper. The D.E.A. agent was flown to a hospital in Fayetteville, Arkansas, while Meese, Hebert, and I would fly back to Mountain Home Regional Airport. By this time the local newspapers had sent reporters to the airport, so Hebert and I asked to be dropped off at the airstrip behind my house, thus avoiding the news media and being photographed. After all, I had to live in the area and nobody needed to know my business—my undercover status as a C.I.A. operative.

I was good for the economy, but not if I was exposed. To my neighbors, I was just an oil worker who made decent money, who would come and go, in and out of the country. I had respect from these people, but only because I gave them respect in return. I often wondered how long this masquerade would last. After my arrest and conviction, my neighbors were stunned, shocked. How could the nice young man from up north be a C.I.A. agent who was responsible for selling tons of drugs to Americans? I wonder if God will ever forgive me and let me pass through His gates to my final destination.

I had enough excitement that day, so Hebert and I would stay at my house for the next two days until the F.B.I. and D.E.A. investigations cooled down a little. Bill and Roger Clinton were already back to the safety of Little Rock, where they would not be exposed, themselves. Oscar Luff stayed and he and Gaston made sure that the cocaine would reach the people who had pooled their money for the large load.

Edwin Meese, then a good friend and confidante of George Bush, called me to meet with him in private at his condo at Gaston's resort. I wondered what this could be about, as I had just seen him two days prior. I would soon find out.

Meese told me that the true purpose of Operation Green Bush was indeed to rid North Arkansas of many of the high dollar marijuana cash crops, so that the stage would be set for the large amounts of marijuana coming in from Operation Delta Dawn, which would start in less than a month. He went on to tell me that Clinton had suggested Operation Green Bush and promoted the whole thing. With the high grade marijuana out of the picture, the price of the pot brought in from Delta Dawn would get high prices—Clinton’s “hold” or fixing of the prices. Meese went on to tell me that Clinton would be setting the foreground for a lot of weapons manufacturing throughout various locations in Arkansas. One of the companies coming to Arkansas from New Jersey to make weapons would be the Brodix Manufacturing Company. This company would later fall under the name of Iver Johnson. Meese also went on to say that a lot of the weapons and their components would be traded for drugs in Nicaragua, through the direct support of Oliver North and with the help of Bill Clinton, and that Bill Clinton would maintain his “hold” on Arkansas.

"GRANDMA WRITES RIGHTS"

GRANDMA AND GRANDPA, A LOVE STORY! (October 26) So many questions have been asked by all of you, such as, "how did you two meet?" and "how long were you married?" and so on.

On a long, hot summer day back in 1952, I had borrowed a friend's Harley and taken off down to Pounds Hollow in Southern Illinois for a swim. While riding down there, an Indian motorcycle pulled up along side of me; it was clean as a whistle, shining like a brand new penny. You could tell it had been carefully restored; the Chieftain logo was as new as could be, as was the rest of the bike. Sitting there on that motorcycle was the cutest "Swabbie" I had ever seen—grinning at me and daring me to race with him.

We raced down to Pounds Hollow—he was teasing me all the way—and it was a nip-and-tuck race. I always thought he let me stay up with him. After we reached Pounds Hollow we went swimming. (He was a great swimmer.) I remember him telling me he was going to Korea and he was concerned about his assignment. I watched those pretty green eyes look way off into the distance, seeing, but not seeing—just deep in thought.

I didn't see Russ again until 1957; I ran into him in Chicago at the Serbian Festivals. We just sat down and talked and talked. He had married, so had I. He had a little girl, so did I. He told me about this MacArthur business, where his unit had been sent up to the Inchon Reservoir to "seek out and identify some P.O.W.s." They had reached their objective and were about 80 yards out when MacArthur called them back; they were ordered to pull back and abort. "Then all hell broke loose," he said. He sustained a blow to the head requiring 127 stitches and his nose had to be re-attached.

I could tell this was not the same carefree "Swabbie" that I had met in 1952 at Pounds Hollow; he was more concerned, more thoughtful. He was still trying to sort things out in his mind. He finally asked me if I would stay over in Chicago for a couple of days, as "I need someone to talk to," he said. I checked in at the Palmer House and spent the next 4 days just listening to my "Swabbie" who had seen so much hell that his mind would not let go.

I discovered he was no longer a "Swabbie," but when I asked him which branch of service he was in, he just looked off across Lake Michigan and said, "In my line of business, I can wear any uniform and it's legal." "Well, just what in the hell IS your business?" I asked. "You really don't want to know, Red," was his reply.

If it bothered HIM that much, I knew that I really did NOT want to know. I had my own bundle of troubles. I was working undercover on "funny money"—those counterfeit \$100s and \$20s that

were floating around, but I didn't tell him about that. His business was his, mine was mine.

I didn't see Russ again until 1969. He was on his way to Vietnam. He had his red hat on and I knew he was in Special Forces—all the way. He had a little time and so we had dinner at Pete's Steak House in Evansville, Indiana. We stayed until closing. I drove him out to Dress Regional, where he had his own plane, watched him taxi out and off into the wild black yonder—and then, I didn't see him again until 1986. While Russ was in Vietnam, I was working undercover checking out the crooked judges in a crooked court system for Jack Kennedy.

When I finally saw Russ again, he had changed so much, I hardly recognized him! He had divorced and had two girls. I had divorced—two girls and a boy. He was still a very disturbed and troubled man. He looked so thin and emaciated, I asked him if he had been ill. He said, “No, prisoners of war don't get the best of food, and I have gone hungry for so long, I just can't seem to get my appetite back.” From the tone of his voice I could tell that something had occurred which he did not wish to discuss—not even with me.

When we finally did meet again in 1986 neither of us was the same. Here we were—the young warriors who were so intent on righting the wrongs—sick at heart from what we had both seen in our quest. Our young minds had become old minds, disturbed by all we had seen. The thought of the two of us trying to sort all this out and do our jobs—in a corrupt system gone mad—boggled our minds!

In 1987 I was working on SAILFIN out on the West Coast. (After Russell's death I discovered he had been working on SWORDFISH—the drug marketing coming in from South America, the Middle East, through Florida and Texas, up to Mena, Arkansas, with deliveries made at every major airport in the Midwest—and distributed by ambulance services!! Russ had stated: “You can tell when these drug runs have come in by the ambulances running up and down the highways with their emergency lights on, at the same time, every day.”) I was sent out by Senator John Morton, who disappeared, and I lost my cover. SAILFIN became full blown! I was in an auto “accident,” which was no accident at all, but attempted murder. I was being held hostage in my own home by the “good old boys” system. I wouldn't walk; I could barely talk. I was in a wheel-chair and being drugged to death. When Russ discovered my plight, he was by my side in a heartbeat. We were together from that day until the day he died.

With Russell's help I began to walk and talk again. Through my rehabilitation, Russell Herrman/Herman and I became as close to “one” as “two” can be, and we remained that way up to the day he passed away (was murdered). We became listeners to a different drummer—a drummer set to the heartbeat of the American people.

One day, we were sitting on the patio talking about all the stories we had been hearing about the farmers being thrown off lands long owned by their families. Each story had the same ending—families losing everything they owned to a crooked system, under color of law, by acts of legal willfulness, without due process. NEW YORK, Nov. 11/U.S. Newswire/—Concerned about the increasing threat of international terrorist activity, the Anti-Defamation League (ADL) and its Leon and Marilyn Klinghoffer Memorial Foundation today unveiled a Counterterrorism Action Agenda for the Administration and the 104th Congress designed to strengthen the U.S. government’s ability to counter domestic and international terrorism.

In introducing the action agenda, ADL National Chairman David H. Strassler and ADL National Director Abraham H. Foxman issued the following statement:

“The international community is experiencing an increasing threat from terrorist activity. The 1993 bombing of the World Trade Center and the recent spate of terrorist attacks in Buenos Aires, London and Israel illustrate all too clearly the continuing threat that terrorism poses to American citizens and interests and reveal U.S. vulnerability. These and other incidents of terrorism at home and abroad dramatically punctuate the need for both American vigilance against such actions and a

tough U.S. response to terrorism.

“Washington can and must take the lead in preventing terrorist attacks by making them more difficult, costly and risky for the perpetrators and the states that support them. Our proposal presents new initiatives and expands counterterrorism efforts already underway in order to maximize U.S. counterterrorism capabilities.”

Following is the ADL Counterterrorism Action Agenda:

Anti-Defamation League Counterterrorism:
An Action Agenda for the
United States Government

1. Create a new Federal Anti-Terrorism statute.

There is currently no comprehensive federal anti-terrorism statute. Since terrorist attacks, by their nature, affect U.S. national interests, American law should provide for broad federal jurisdiction—with substantial criminal penalties—for terrorist acts committed in the United States.

2. Deny terrorists and their supporters access to the U.S.

Visas should be presumptively denied for terrorists and their supporters who come here to raise money.

Improve inter-agency communication to ensure that the most current comprehensive intelligence information gets to the consular officials who make visa decisions abroad.

Streamline deportation proceedings for alien terrorists and more effectively screen political asylum requests, consistent with appropriate constitutional safeguards.

3. Expand and toughen prohibitions on providing material support for terrorism and terrorist organizations, such as training, weapons, safehouses, fundraising and financial services.

4. Examine the use of the RICO statute for fighting terrorism.

Terrorists are criminals and their activities should be regarded as ongoing criminal enterprises.

5. Enhance administrative response of federal agencies.

Preserve an independent State Department Counterterrorism Office with an ambassadorial-rank coordinator with direct access to the Secretary of State.

Increase funds for counterterrorism research and development.

Improve inter-agency coordination and establish a central repository for terrorist threat informa-

tion.

Facilitate information networking and expand analytical resources, such as translators.

6. Increase pressure on U.S. allies to make counterterrorism efforts a priority and to develop a coordinated strategy.

Counterterrorism should be an ongoing agenda item at every multilateral diplomatic forum and high-level bilaterals.

NATO/G-7 allies should decline loan rescheduling requests from state sponsors of terrorism.

The United States and its allies should oppose aid by World Bank/IMF to terrorist countries. Make them choose: terrorism or access to development funds.

Establish an international counter-terrorism rewards program to encourage intelligence gathering leading to prosecution for terrorist crimes.

7. Increase the diplomatic, military and economic costs for U.S.-identified state sponsors of terrorism.

Restrict technology transfers to state sponsors and third countries that support them.

Expand commercial sanctions, including export credits, and restrictions on imports and landing rights.

8. Amend the Foreign Sovereign Immunities Act to provide explicit jurisdiction for lawsuits against countries that support or condone terrorism, torture or genocide.

9. Raise public awareness.

Terrorism should be a continuing priority for the 104th Congress and the Administration, not just an episodic concern.

TECHNOLOGY AND LIBERTY

Push has come to shove. The FBI's nightmare Digital Telephone and Privacy Improvement Act is about to reach the floor of both the Senate and the House. In the House, the bill is HR 4922. It's S. 2375 in the Senate.

The draft bill legalized automatic, computerized telephone surveillance through Americans' telephones and communications networks. But don't worry—the FBI promised to obtain a court order from somewhere before switching the system on in your house.

Well, the FBI's proposed PIA has changed. A key congressional staffer directed some alterations to the bill's language before it was introduced to our elected representatives. (And the changes are just as interesting as the new, high-paying job the staffer obtained after he convinced his boss to sponsor the bill.)

So take a seat, loosen your collar and get ready for the new, improved PIA. Your elected representatives could enact this thing as law in the next two weeks if you don't protest this.

PRIVACY "IMPROVEMENT"

For starters, the PIA has a new name. Now it's called the Wiretap Access Bill (WAB). They had to change the bill so it spends more of your money, too. Now it authorizes the FBI to pay \$500 million taxpayer dollars to America's local telephone companies. This expenditure accomplishes two important objectives. First it establishes the price of your privacy: Nothing. Second, it addresses the Constitutional and business concerns of America's phone companies—the FBI pays them and they shut up.

In exchange for your \$500 million, the phone companies will modify their equipment so you have no privacy. Within four years, all telephone company switches and networks must be modified so the FBI can instantly identify who you telephone and who calls you, according to the provisions of the bill. And your \$500 million buys even more. (Leave it to the FBI to drive a hard bargain.)

Phone companies will also install "special equipment" to allow the FBI to automatically eavesdrop

on you whenever they want. The phone companies will, in turn, bill you for the maintenance of this wonderful system.

AUTOMATIC KGB

Now we come to the bill's boring technical details—the sort of drudgery that legislators routinely delegate to their hapless staffers. This includes, in this case, a key staffer (he must remain nameless) who created the language of the WAB and then suddenly departed for a much better job at a privately funded foundation.

Hidden in the bill's "legalese"—and unmentioned in any of the FBI's congressional lobbying for its precious PIA—is something even more sinister. The bill calls for telephone companies to provide instantaneous, contemporaneous, automatically activated eavesdropping on people in their homes or businesses. That's push-button surveillance from thousands of miles away. It's right there, in the language of the bill. Phone companies that fail to give this power to the FBI are fined \$10,000 a day.

And our wanna-be secret police didn't pull this language out of thin air. This grim law was literally dictated by the 1990 design specifications of the computerized equipment that will breathe life into this secret, automatic KGB.

The true intent of the WAB is revealed in a little-noticed set of "Technical Requirements" documents from Bell South, dated 1990. These documents, summarized in out-of-the-mainstream technical magazines, describe a remote controlled, computerized monitoring device. It goes on your neighborhood telephone pole—or, even better, in an out-of-the-way underground telephone circuit. It "runs encrypted"—so even the telephone company can't determine who activates it, how it's programmed or what it's doing.

This device is called a remote monitor. It's nicknamed the "smart box." It can eavesdrop on an entire residential neighborhood. And be assured, fellow citizen, it's a quality product. Unlike our wobbly B-1 bomber with \$700 toilet seats, the smart box documents describe a grueling six-city test of the device—blanket surveillance of major metropolitan areas. The smart box passed with flying colors.

UNTHINKABLE BILL

Do you like the sound of this? The legislation is completely unthinkable in a free country. And yet it is before Congress now, apparently on a fast track for a quiet vote before the October recess for the elections. This Teflon-coated monstrosity has arrived on the legislative calendar despite outrage and disbelief by citizens and computer professionals who are stunned by the bill's amazing progress.

The consensus among computerists and citizens is: "This can't be happening." But it is happening—despite very serious questions and demonstrable inconsistencies in the testimony FBI Director Louis Freeh gave before Congress on the bill.

And why the Establishment media silence? You probably heard about remote monitors and the PIA first in The SPOTLIGHT. I bet you haven't heard about it anywhere else. Why?

What kind of Congress will we have with invisible, untraceable, remote-controlled surveillance built into our telephone networks? How independent will our judiciary be when the smallest peccadilloes of every judge are stored on computer tapes for fast playback? What sort of free press will we have if the phones are unplugged or "unofficial" sources are fingered and sandbagged before they hang up the telephone? Who will dare to call independent journalists or civil libertarians when all telephone numbers are permanently recorded and computer scanned?

What legal confidentiality will we have when our lawyers' phones are automatically tapped and their offices bugged? What business can we transact by phone or fax or modem when politically connected competitors could be listening? Dare we fax our patents or proposals? (Ask the folks at Inslaw, Inc.)

And what's the price of freedom? It's \$500 million to you; nothing to Bill Clinton and the FBI.

On a personal note, I'd like to thank the infinitely patient editors of the SPOTLIGHT and the many thoughtful readers who have inquired after my well-being these past six weeks. VINCENT FOSTER'S DEATH: WAS IT A SUICIDE?

STILL AN OPEN QUESTION

- *The gun had only two bullets (**no matching bullets were found in his home**);
- *Foster fired the gun using his right hand, **even though, according to the Boston Globe, he was left-handed**;
- *Despite the explosive recoil, **the gun remained in his “opposite” hand**;
- *Although Foster allegedly had placed the gun’s barrel deep into his mouth, **no blood was visible on the gun, no teeth were damaged or broken**, and save for some powder debris on the wound itself, **no powder burns were found in the mouth**;
- ***No fingerprints were found on the gun**, which was found neatly at his side;
- *Despite the violent manner of death, his body fell into a stereotypical death position **with arms arranged perfectly at his sides**, as “if he was ready for the coffin,” as one paramedic put it; and
- ***Only a small amount of blood** was seen.

WHY WE ALL SHOULD CARE

As Deputy White House Counsel, he was the highest-ranking federal official to die under mysterious circumstances in 30 years.

The American public has a clear and pressing right to know the circumstances that led to this high-ranking federal official’s death.

On July 20, 1993, the night Vincent Foster died, at least three senior White House aides—Bernard Nussbaum, Patsy Thomason and Maggie Williams—admitted they entered Foster’s office and removed files. **Why were these senior aides, late at night, and only hours after Foster’s untimely death, rushing into his office to remove files? ***Unlike every other aspect of Fiske’s Whitewater investigation, no one involved in the Foster case was placed under oath. Why?**

WE HAVE A RIGHT TO KNOW

Don't we all deserve answers to the following questions?

*Where was Foster in the hours prior to his death?

*Why didn't the government investigate how carpet fibers of various colors came to be all over his expensive clothing?

*Why was Judge William Sessions hurriedly fired the day before Foster's death, leaving no permanent head of the FBI for several weeks?

*Was the investigation, as Sessions has charged, "compromised from the beginning" by this action?

*Why were the Park Police given exclusive jurisdiction over the investigation of the death of such a high-ranking White House official?

*Why was an inexperienced officer—someone who had never conducted a homicide probe—permitted to serve as lead investigator?

*Why did the Park Police, within hours of Foster's death, give away critical pieces of evidence, like Foster's pager? And the next day, his personal effects?

*How could the most elemental part of any homicide investigation—the key crime scene photos—have been "underexposed" in the Park Police labs?

*How could Fiske so easily accept the medical examiner's explanation that there were no X-rays of Foster's body, when both the autopsy report and the Park Police report clearly state X-rays were taken?

*Why do blood tracks on Foster's face indicate his head assumed four distinct positions after his instantaneous death?

*How did blood run uphill, as one of the blood tracks on Foster's face shows, when his head was found in a normal, straight-up position on a steep slope.

*Why did neither the Park Police nor Fiske's investigators follow basic police practice by interviewing the many neighbors around Fort Marcy Park to see if they heard or saw anything unusual that fateful day?

*Why didn't anyone interview the person who spent the previous weekend with Mr. and Mrs. Foster?

*Why did Fiske's investigators, according to published reports, badger the confidential witness into changing his testimony about the crime scene to fit their own conclusions?

*Why were observations by emergency workers noting additional wounds on Foster's head not recorded in their official reports?

*How did the FBI find traces of two drugs in Foster's blood when the original medical examiner's blood analysis found none?
